

Will. of William Hinnant Jr

North Carolina Johnston County In the name of God Amen
 I William Hinnant Jr being of sound perfect mind and memory
 blessed be God do this 18th day of January 1818 make and publish
 this my last will and testament in manner and form following
 that is to say first I give to my loved daughter Patience Hinnant
 two negroes by the names of Smith and Jack also one feather bed, be-
 dstead and furniture one bay felly bridle and saddle one chest two
 cows and calves two sows and pigs two ewes and lambs one pew-
 dish bason and six spoons and six plates one spinning wheel and ear
 two sitting chairs one iron pot & hooks and fleshfakes one ladle

Item I give to my beloved son Edwin Hinnant two negro boys
 by the name of Allen and Tom one gray mare saddle and bridle
 two cows and calves two sows and pigs two ewes and lambs
 one feather bed bedstead and furniture one dish bason and six
 spoons and two plates one pot & hooks one half of my brandy still
 and the other half to my son Stephen Hinnant and also one
 half of my blacksmith tools and the other half to my son
 Stephen. Also I give to my son Edwin one walnut table and
 one large chest and one shot gun one and one weeding hoe one
 grubbing hoe and one hand saw and one half of all my cash
 and the other half to my son Stephen, to Edwin one case of knives
 and forks and four sitting chairs one iron wedge and one to my
 son Stephen also to Edwin one grindstone.

Item I give to my granddaughter Sally Revell one negro girl by the
 name of Melly also one feather bed bedstead and furniture one
 chest and two womens saddle six pewter plates one dish
 bason and six spoons one dutch oven and spider one spinning
 wheel one washing tub and bread tray one cow and calf if
 she lives to the age of eighteen years.

Item I give to my beloved wife Sarah Hinnant two horse creatures
 Ball and Fern also the cattle that haint been already mentioned
 all my hogs haint been mentioned all my sheep haint been
 mentioned the stone goods to be sold one hundred and fifty
 acres of land to be sold near Stephens Mill one hundred
 acres near Cape Fear to be sold all my negroes that has
 not been mentioned I lend to my wife during her life or
 widowhood and all the rest of my estate be of what soever kind
 or nature I lend to my beloved wife during her life or
 widowhood and after the death of my wife or widowhood all

the property which is given away to be sold and Sally Revell
 to have one hundred dollars of the said money if she lives to the
 age of eighteen years old also one hundred dollars of the said
 money I give to my son Josiah Hinnant. The negroes to be sold
 in the family and the money arising from all the sales to
 be equally divided amongst my seven children (to wit) William Hinnant
 Zippa Gornier Sarah Barnes Josiah Hinnant Stephen Hinnant
 Patience Hinnant Edwin Hinnant. Signed Sealed and delivered in
 the presence of us the day and year above written I do appoint
 my beloved wife, Stephen Hinnant and Elias Barnes executors to
 this my last will and testament in witness whereof I have here-
 unto set my hand and seal
