or kind it may be during her natural life and after
her decease to be sold and equally divided among all
my children, namely as follows, James, Feby, John,
Trany, Mary, Nepier, Serena, Aaron & Isaiah

I hereby nominate constitute & appoint my wife
Elizabeth Wood & my son Sr. Wood executors to the
my last Will & Testament hereby revoking & annulling
all other wills by me heretofore made I am Testimony
whereof I have hereunto set my hand & Seal this day
and year within written

to her her heirs and assigns for ever

5th I give devise & bequeath to my sister Sevil
Dunbar one Shilling Sterling to her her Heirs
and assigns for ever

6th I give and bequeath unto my sister Minny
Kerret one Shilling Sterling to her her Heirs and
assigns for ever

7th Seventhly I give & bequeath to my nephew
Lewis Morris one Shilling Sterling to him his
Heirs and assigns for ever

Lastly, I hereby revoke all other wills by me made
acknowledging this to be my last Will & Testament
Signed with my seal & dated this 12th day of
October Anno Domini 1811
