Item I give & bequeath unto my well beloved Brother Clement
Richards my black mare & bay horse as also all my stock of
Cattle or Hock of any other kind whatsoever as also one half.

part of my household furniture unto the R. Clement Richards
his heirs and assigns forever and no more of my share of what
kind soever.

Item I give & bequeath unto my well beloved Sister Sarah Pri-
chard my negro woman named Bett as also the remaining part
of my household furniture except the Box of furniture which
my Mother Mary now makes use of unto the said Sarah Prichard
her heirs and assigns forever & no more of my share of any kind.

Item I do further give & bequeath unto the above mentioned Bayle
Richards all my plantation plants of any kind or nature
whatsoever unto the R. Bayle Richards his heirs and assigns forever.

As to my real Estate I give and bequeath the plantation whereon
I now dwell unto Bayle Richards his heirs and assigns forever
also all the Land Encroachments in any way to be recovering
in any place whatsoever I give & bequeath unto the said Bayle
Richards his heirs and assigns forever & as hereby nomi-
nate & appoint the said Bayle Richards Executor of this my last
will & Testament fully revoking all former will or Wills by me
heretofore made His Witnesses others of Grace however let my hand
be set this 10 day of July 1793.
