Then was the within last will & Testament of
Richard Roberts dec^d produced in open Court & proved by the oath of
Robt. Dickson & Jerry Watson two of the subscribing witnesses & ordered to be record-
ed at same time the executors therein named qualified as such agreeable to
law ordered that letters Testamentary issue accordingly

In the name of God amen the first day of August 1814. I Elijah
Sanderson of the County of Jones and State of North Carolina being very
sick and weak of body but of perfect mind and memory, thanks be given unto
God for it therefore calling unto mind the mortality of my body and knowing
that it is appointed for all men once to die do make and ordain this my last
Will and Testament that is to say principally and first of all I Give and
Recommend my soul into the hands of God that gave it and my body I
recommend to earth to be buried in a decent Christian burial at the discretion
of my Executors nothing doubting but at the general resurrection receive same again
by the mighty power of God and touching such worldly estate as it pleased God
to bless me in this life - I give and dispose of the same in the manner
and form Imprimis -

I give unto my son Joshua one Hundred and Twenty Acres Land
 lying on mill creek a joining Blader Slights and Thomas Frys Land
 also I give to my son Joshua two negroes by the names of Chafer and
 Milley one Horse Saddle Binde by the name Sorrel Two Beds and One
 Bed Stia and the Furniture to be equally divided - I give unto daughter
 Nancy one Hundred and Eighty Four Acres of Land lying on the
 North side of Trent River a joining George Pollocks and Lewis Sandersons
 lands also I give her two Negroes by the names of Clingo and Spice
 also One Horse Saddle & Bridle the Horse is name Black also Two Beds
 and One Bed Stia and an equal share of the Furniture - I give my dau-
 -ghter Polly Fifty Acres of Land lying on the East side of Mill Creek
 adjoining of Thomas Frys Land also I give her three Negroes by the
 names of Primas Bill and Toney also One gray colare a Year old
 lost Spring Saddle and Bridle also Two Beds and One Bed Stia and an
 equal share of the Furniture and all the remainder of my property to be
 sold and after all my just debts and reasonable charges is paid and
 the remainder to be equally between my Three Children and likewise
 constitute make and ordain my well beloved son Joshua and John
 Sanderson my Executors of this my last will and Testament I do
 hereby utterly disallow and revoke and disanul all and every other
 former Testaments and Will Legacies and Executors by in any ways
 before named Willed and Bequeathed ratifying this and conforming
 this and no other to be my last Will and Testament in witness
 I have hereunto set my hand and seal the day an Year above written
