and Ordain this my last will and Testament in manner and form following
(Ora) I pray Impromas - I wish my body to be decently buried in a Christian like
Manner by my Executors herein after named and after my funeral
expises is all satisfied & paid I leave what little Property it has pleas
God to bless me with, as follows; 1st Item my will is that all my just
Dolls be paid out of my monies arisen from sales or otherwise not
differently disposed off; 2nd Item I give and bequeath unto my Son
Francis Andrews one negro boy Ned now in his possession to him his
heirs and assigns for ever; 3rd Item I give and bequeath unto my Son
Andrews one negro woman Pops to him his heirs and assigns for ever,
4th Item I give and bequeath unto my Daughter Susan Edwards three
negroes women and child Betty & boy Moses also one young
Black Man called Raleigh. Also one half of all the pinter land about the
house. also one half of all my Lands lying on the Lower East side
of Muskehell branch. also one cow and calf to her heirs and assigns forever.
5th Item I give and bequeath to my daughter Sarah Marret and hundred dollars
in cash to be raised from the sales of my estate. also two negro
women Esther and her child Sonam now in her possession. to her heirs
and assigns forever.
6th Item I give and bequeath unto my son Peter Andrews negroes
Lexin now in his possession, and Aaron. also fifty acres of Land on the
Upper or West Side of Muskehell branch to him his heirs, and assigns forever;
7th Item I give and bequeath unto the heirs of my daughter
Mary Marret. One negro woman Viller and her children now in the
possession of James Marret to them their heirs and assigns for ever
8th Item I give and bequeath unto my daughter Vilia Moon negroes. woman
Sinah to her, her heirs and assigns forever.
9th Item I give and bequeath unto the heirs of my son Adam Andrews ten dollars
to be equally divided among them. to them their heirs and assigns forever
10th Item I give and bequeath unto my daughter Lucy Andrews one
half of all my Lands lying on the lower or East side of Muskehell branch

also negro boys Titus and Dick & Leger Rachel also 3 Beds and furniture
one half of all the water worn about the house. One two year old mare called
Flower one dish and one large dining table. two cows and calves. to her
her heirs and assigns forever.

13th Item. I give and bequeath unto my daughter Susan Edwards above
mentioned. one other negro woman Clara to her, her heirs and assigns forever.

14th Item. I give and bequeath unto my Grand son James Adams one hundred
dollars to be raised out of my estate, to him his heirs and assigns forever.

15th Item. My Will is that all the residue of my property realty and personal
not heretofore divided and given away be sold at six months credit
and after all my just debts are paid. the residue with all money due me
in any way within by note or account to be equally divided among my
three daughters Susan Edwards, Leah More & Sewey Andrews to them
their heirs and assigns forever.

Lastly I nominate and appoint Francis and Peter Andrews executors
to this my last Will and Testament. overruling all other wills by me
heretofore made. acknowledging this to be my only & last Will. In Witness
Whereof I have hereunto set my hand and seal. This the 9th day of
