 Head of Cattle also two Horses named Duncie & Roaling and
 two feather Beds & Furniture with all my Stock of Hags &c.
 and her Lins and apers forever

2.^d I leave my Wife Hannah Morda all the rest of my Disable
Estate Except those things hereafter Mentioned bequeathed to my
Children during her Natural Life

3^d Give and Bequeath to my son Thomas, Mearls all my Land
in Berkshire County by Estimation Two hundred and forty
nine acres also one feather bed and furniture and horses named
Ruffen and Brandy with the rest of the stock and other articles
which he Rec. of me at his marriage to him his heirs and
Assigns forever

^{the} Yours and Bequest to my Daughter Tryphena West one
feather Bed & furniture one Brass bedstead fancy two lead
ships with other articles which she Rec^d at her Marriage
to her son Richd and Ours forever

5th. Skins and Regiments to my Daughter Hannah Collins. one
feather bed and parurel two heads of Cattle one pair
two heads of Sheep with other articles the rest at her Mar-
riage to her and her heirs & assigns forever

Wth gave and bequeath to my Daughter Barbara all that three
heads of cattle in Mar one feather Box & furthermore two
head sheep and all the hay marked in her mark to her
her heirs and assigns forever

9th I give and bequeath to my Daughter Rachel all and
further bed and furniture the main one bed and calf one
one two year old heifer and two head of sheep and all the
hay marked in her mark to her and her heirs and assigns
forever

8. ^{John} My wife and I agree is that those things before mentioned
which is but long wife, Hannah should that she should
dispose of as she may think proper to Each or either of
my Children at her own Discretion

4th And lastly I Nominate and Appoint Charles Thomas
Oliver and My Neighbour Jarvis Withers Executors of this
 my last Will and Testament Revoking all other Wills before
 made by me acknowledging this and the only to be my last
 Will and Testament as a Witness I have signed and sealed and
 acknowledged the same - this fourth of January 1789
