

In the name of God Amen I Mary Spight widow of Jones County and State of North Carolina. do make and publish this my last will and Testament - in manner and form following that is to say first of all I give and bequeath my soul into the hands of God that gave it and my body to the earth to be buried in a decent manner. and leaving my worldly goods - - -

Item 1st I give and bequeath to my son Sharp Spight five Shillings Sterling to him his heirs and assigns forever

Item 2^d I give and bequeath to my son in law Benjamin Harrison five Shilling Sterling to him his heirs and assigns forever -

Item 3^d I give and bequeath to my son Thomas Spight one large red chest one of chain and one crop but I leave to him his heirs and assigns forever -

Item 4th I give and bequeath to daughter Hellen Harrison one negro woman named Sarah to her her heirs and assigns forever

Item 5th I give and bequeath to my daughter Polly Thomas one negro woman named Sall to her her heirs and assigns forever -

Item 6th I give and bequeath all the rest residue and bulkance of my property or estate of every kind or nature whatsoever consisting of Horses. Cattle. hogs. Sheep. Horse hold. and kitchen furniture. of every kind or nature whatsoever all my stock of every kind and farming utensils of every kind my corn and wheat chain. and hoes. all my crop that may be in houses or out of houses and finally the rest of my estate that is not particularly named. In the following manner that is to say to be sold at a fair and

publick sale by my Executors hereafter to be named and the hole of the money arising therefrom to be divided into three equal shares or divisions that is to say my wife and I leave so for my son Thomas Spight to have one equal share my Daughter Polly Thomas to have one equal share and my four grand sons named Everett Miles John and Ira Spight to have the other one equal share to them their heirs and assigns forever.

And lastly I nominate and appoint my loving son Thomas Spight my sole and sole Executors of this my last will and Testament In witness whereof I have hereunto set my hand and seal this 1st day of June in the Year of our Lord 1817.
