

In the name of God Amen.

I Shadrach Mallard of the County of Jones and State of North Carolina being at this time in good health and sound mind & disposing memory do make & ordain this to be my last will & testament in manner & form following -

Item 1st I recommend my soul to Almighty God that gave it me and ^{my} body to the earth from whence it was taken to be decently entred at the discretion of my Executor herein

after mentioned and as for such worldly goods as it hath pleased God to bless me with I give demise & bequeath in manner and form following (viz)

Item first It is my will and desire that all my Chest bills and funeral expences be discharged & paid -

Item 2nd I give demise and bequeath unto Daniel Harrison son of William Harrison a piece of land owned by me in what is called Calbin Island on the piceson containing by estimation two hundred Acres more or less to him his heirs and assigns for ever

Item 3rd I give & demise unto John Harrison son of Melby Harrison a piece of Land beginning at a pine a corner of the Colwell patent commonly called the Peter's Corner thence a direct line to Chumping run at the Crossing of Daniel Harrison's bridge above the House thence down said Chumping run to swim Harrison's line thence with said Harrison's & St. Fowlers lines to the beginning to him his heirs and assigns for ever -

Item 4th I give demise & bequeath unto Mary Harrison daughter of Stephen Harrison decd. all the rest and residue of my Estate real & personal, but in the event of said Mary dying without lawful issue then it is my will that the lands hereby given to her devolve to John Harrison son of Melby Harrison, unto them their heirs and assigns forever -

Lastly I nominate constitute and appoint Mary Harrison daughter of Stephen Harrison decd. Executor to this my last will & Testament ^{making} all others by me heretofore made acknowledging this to be my only Will, in witness whereof I hereunto set my hand & seal this 15th November 1837 -
