

Know all Men by these presents that I Silas J. Perry of the County of Jones and State of North Carolina being of feeble Health but sound in mind and memory do make this my last will and testament hereby revoking all former and Codicils of every kind soever.

First I give and bequeath to each of the children of my Sister Susan Pthem deceased being four One Slave and four Hundred dollars.

Second I give and bequeath to my Brother George W. Perry all the balance of my property of every kind soever after paying the legacies above specified to my sister children my just debts and funeral expences

Third I hereby make and constitute my Brother George W. Perry my Executor to carry into effect this my last will and testament

In witness whereof I have hereunto set my hand and seal at Norville in the State of Alabama this sixteenth day of December A.D. 1845

the above instrument was subscribed by Silas J. Perry the testator in the presence of each of us and was at the same time declared by him to be his last will & testament and we at his request signed our names hereto as attesting witnesses

Whereas we are informed by the Petition of George W. Perry of the County of Jones and State of North Carolina that Silas J. Perry late of said County of Jones and is dead and hath made a last will and testament in writing and thereof appointed said George W. Perry Executor and that the said Silas J. Perry at the time of his death had his usual and fixed residence in the said County of Jones by reason whereof the probate of the said last will belongs of right to the County Court of Pleas and Quarter Sessions for said County and whereas we are further informed by the said George W. Perry that the said last will is attested by C. Lockwood A. A. Winston and J. Torrey who are inhabitants of the State of Alabama resident therein by reason whereof their personal attendance

in the said County Court for the purpose of proving this said last will cannot be had. Now know ye that we reposing special confidence in your fidelity and prudence have appointed you and by these presents do give unto you full power and authority to cause the said E Lockwood A. A. Winston and S. Dory or any two of them to come before you at such time and place as you shall appoint and them or any two of them examine upon oath which oath you are hereby empowered to administer touching the due execution of the said last will of the said Elias J. Perry and the state and situation of his mind at the time of executing the same and such examination together with this writ closed up and under your seal to the Justices of this County Court of Pleas and Quarter Sessions for the County of Jones at a Court to be held at Tomton within and for said County on the second Monday of June next
