I give and devise to my dauf't daughter Elizabeth Harris ten dollars which  
is to be paid by my executor so June as the same can be collected.

I give and devise to my daughter Catharine ten dollars which is to be paid  
in the same manner as above named.

I give and devise to my daughter Sarah ten dollars which is to be paid  
by the executor as above named.

I give and devise to my daughter Polly ten dollars which is to be paid by the  
executor so June as he lawfullly remitteth.

I give and devise to my daughter Liza ten dollars to be paid in the same  
way as above named.

I give and devise to my son Misty ten dollars to be paid in same way  
as above, I give and devise to my son Peter Harris one dollar, I give  
and devise to my daughter Amy his one dollar, I give and devise to my

I give and devise to my son Hasty ten dollars to be paid in same way as above, I give and devise to my son Peter Harris one dollar, I give and devise to my daughter Susan & John M. Kee all dues and monies that may fall in my hands after paying this heirs and expenses of my funeral. The balance is theirs. And I do hereby constitute and appoint my lawfull Executor John M. Kee to all interests supposed to execute this my last will & Testament according to the true intent
