I, Daniel Hovee of the County of Sincere & State of North Carolina, Do make & declare this My last Will & Testament, In manner & form following

First I resign my soul into the hands of Almighty God, Hoping & believing in a remission of my sins by the Merits & Mediation of Jesus Christ & My body I commit to the earth to be buried at the discretion of my executor or executors hereafter named of my worldly estate I give away as follows First It is my Will that my Son Daniel Hovee is to have my dark brown horse with a blaze in the forehead & Two ten Dollars in money to buy a saddle & bridle One Cow & Calf his Choice Two head of sheep his Choice Second It is my will that my Daughter Anna Hovee is to have my brown Mare three years old with a blaze in the forehead, Two Cows & Calves his Choice, Two head of sheep his Choice Two heads & bodies his Choice, One Cow & Calf his Choice I take his Choice, & Candles & Tallow One small Wheel & One pair of bars his Choice & Twenty Five Dollars in money to buy a saddle Bridle & house furniture

3^d It is my will that my son David Hovee is to have my bay Mare One Cow & Calf his Choice Two head of sheep his Choice & Two ten Dollars in money to buy a saddle & bridle & two set of horse gear.

It is my will that my beloved wife Ann Hovee

I do have during my life Natural life or Maturity
Held the Liberty of my plantation of house to occupy
& all the other buildings on my plantation & I will
& guard it all the while & take care of it
such specified as hereinafter before mentioned the
Twenty four hour Clock & Case, the pocket Clock
to be sold his bed saddle & bridle, Gun powder
and all the ammunition belonging to it, all the
Spinning Wheels & Cards, Clock and Wash pot
of Cob Cham, & that my wife we is to have my
Negro boy Obrian during his natural life
or Maturity Held & after his decease the above named
property which she may leave to be sold by Executor
or Executors & the Money arising from the sale
to be applied as herein after mentioned

It is my will that my son David Horner
Is to have the plantation I now live on & all
my land which I have bought, adjoining the
land about five acre of Meadow Ground
Lovingly with Horner, & Henry Sister & the
Threshing Machine, & my son David is
to provide & furnish my wife our wife Clothing
& provision sufficient for her decent support
during his natural life or Maturity Held
Negro boy Obrian & by my son Obrian

David should fail or neglect to provide as
above mentioned him my wife our shall be
at liberty to lease or rent out a part or the
part of the before mentioned lands or plantation
to give her decent support during her natural

Sixth It is my will that the sum which I have
given to My son Ephraim & to be Valued by three
disinterested persons, one to be Chosen by myself
Ephraim, & the other two to be Chosen by my
Executor or Executrix, & if said value is Valued
for a librum in proportion there will be a
Remaining out of the surplus Money which
may be left in the hands of My Executor
or Executrix, then My son Ephraim is to have
as much as will make him equal in sum
with My son Absalom, John Horow, Philip
Horow, Daniel Horow & My daughter Anna
Horow, & if Valued as high or higher, than
he is to receive no more of My estate
Fourth

It is my will that all My Realty real or
personal not above Mentioned or having
After Mentioned, is to be sold by My Executor
or Executrix & the Money arising there from
to be applied to pay my Just debts & all my
expenses & the balance to be equally divided
between My Children as follows. My sons
Absalom, John, Philip & Daniel Horow & my
daughter Anna Horow, & My son Ephraim
Horow If he is not equal as above Mentioned
than he is to have less than to make him equal,
Eighth

It is my will that the Money arising from
the property which I have left to my property

January 1st instant 1835

Wife One is to be divided among all my Children
who are named in the 4th Article, & as there is divided
of it is My Will that these freeholders are to be chosen
by My Executors, who are to lay off out of My
Stock, Crop, & provisions, which will be sufficient
for the support of My wife One, my son David
My daughter Anna, & negro boy Cihacian
for One Year & no More.

Also It is My Will that my beloved Son Andrew
Hoover & my trusty friend Daniel Comer be
My executors In witness where of I have here
unto set my hand & seal 23rd of November

1837
