and Testament in Manner Following that is to say
I first give my soul to Almighty God who gave it and
my body to the dust from whence it came and to be buried
as hereinafter directed as touching my worldly estate where
God hath blessed me with, I first give & bequeath
unto my son David Beam the sum of five Dollars out
of my personal Estate to be paid to him by my Executor
2nd I give all and Singular my Land ~~My~~ ~~my~~ ~~my~~ ~~my~~ ~~my~~
unto my friends Solomon and John Duvor for themselves
Always forever the Land I Bequeath lies on the Waters
of Warlicks Mill Creek and Banges Saw mill Branch
Containing 43 acres all of which I give & bequeath unto
the said Solomon and John Duvor - In order that it
may be better understood my son David Beam has not
got the natural Faculty of mind as that he can maintain
himself I therefore make the above bequest of
my Land to the said Solomon & John Duvor for which
I direct and they agree to maintain me and my son until
our Natural Deaths and to find us Both in Sicknes & in ~~in~~
Good & Sufficient diet Cloathing and Lodging as becomes an
Old person and in Addition to the Diet Cloathing & Lodging
they agree to pay a fifty Dollar Note I owe to Daniel Dutz
Also further I give & have given unto the aforesaid Duvor
at this time possession of my Land in as full a term as if
it belonged to them at this time but they are to have no
other Right until my Natural Death but then they are to
have my Land for the above Consideration except they
are to have my body decently buried in a Christian
like manner and also to have the body of my son
buried in like manner they are to provide and main
tain my son David during his Natural life and then
they are to have & to hold all my Land I now own
and possess which Land they are to hold & Possess
for themselves & their heirs forever against the claim
or claiming of every other person or persons whatsoever

provided always that the said Powers is to main-
tain me & my son our natural lives and in case they fail
to provide for my son's decent living for my son it shall be expedient
for my son to make application to the County Court of said
County and the said Court shall decree in what manner my
son shall be maintained out of my Estate but the decree
shall not be made without a full investigation of the case
As touching my personal Estate I shall not dispose of it at
this time more than the five Dollars my son David is to have
I appoint and ordain my friend John Flagle my executor of
this my last Will & Testament, signed sealed Published
and pronounced & declared by the said David Beam Senr as his
last Will & Testament in the presence of us who in his
presence and in the presence of each other have hereunto

As touching my personal Estate I shall not dispose of it at this time more than the five Dollars my son David is to have.
