to the care for the distribution as will be taken of enter-
tained. She is to have the sole management of my estate
except what is hereafter expressed during the period
above mentioned named to Celia & all debts owing to
me to defray my funeral expenses to pay all my debts
and to educate & bring up our son Charles I should it
be her desire that my son Thomas Hollinger & Celia should
& income be hired out & sold it is my will that my executors
hereafter named are at all times to act in accordance
& apply the proceeds accordingly to the above account.

It is further my will that Henry Canister Esq. & Daniel
Finger be my executors of this my last will & testament
and I do hereby revoke all former wills by me made.

2nd I give & bequeath unto my son Joshua 1 pair
stamped furniture 1 young mare named Health, one
I plow 1 Matay ~~I have by~~ I have my Shee Punch & all
my shoe making tools my hand saw, Plane & several other
iron wedge.

3rd the rest of my Children I have give them their
full share and allow them no more, the three
pewter plates above named & allow to my son Joshua

4th & I hereby make, make & ordain my wife Elizabeth
& my son Joshua Executors of this my last will & testament
be witness whereof I the said Hiram Penlton have to this
my last will & testament, set my hand seal the day
& year above written
