except what is hereafter expressed during the period
above mentioned named. To collect all debts owing to
me to collect my General of, penses to pay all my debts
and to educate & bring up our sons & children. Should it
be her desire that my negro Woman Elizabeth & Child should
be hired out or sold it is my will that my executor
hereafter named hire or sell the same as she may direct
& apply the proceeds agreeably to the above devise.

It is further my will that Henry Cassler Esq & James
Finger be my Executors of this my last will & testament
and I do hereby revoke all former wills by me made.

the half of my hogs if I have any at my decease, one
Iron Wedge & all my Books

2nd I give & bequeath unto my son Joshua 1 new
stead & furniture 1 young mare named Heitch. 1 cow
1 plow 1 Matax 1 hoe & 1 hoe my shoe Punch & all
my shoe making tools my hand saw State & Jencid one
Iron Wedge.

3rd The rest of my Children I have give them their
full share and allow them no more. The three
pewter plates above named & allow to my son Joshua
& I hereby make make & ordain my wife Elizabeth
& my son Joshua Executors of this my last will & testament
In witness whereof I the said Hiram Puncton have to this
my last will & testament, set my hand & seal the day
& year above written
