In the Name of God amen.
I Hugh Jenkins of the County of Lincoln &
State of North Carolina being weak in body
but of sound mind & Memory & Calling to mind
that it is appointed for all men Once to die
Therefore in Order that I may settle my worldly
affairs do make this my last will & Testament
Wif. It is my will that all my just debts (if any)
& funeral Charges be paid out of any debts coming
to me. It is my will that my beloved Wif
Susanah Jenkins have & possess the tract of land
whereon I now live but no Mills to be built
at the shore on the Creek. where the present
Road now crosses & further James H White is
to have possession of one end of my dwelling
house twelve months after my decease & power
to build a house on said tract at such place

November 1855

as he may think convenient to water & the Mill
to.

I also will my said wife Susan make
the same possession & use of my other tract & land
called the West tract except the upper meadow then
on that I now enjoy but the two game law now
living thereon are to have the same possession &
privilege they now have but to bring no other than
the above possession & profits called to my said wife
she is to enjoy during her widowhood & then they
are to be distributed as follows. The whole of
the tract that I now live on I bequeath to James
H White to have & to hold & the other tract to go
to my brother David, two youngest children
William & Mary to have & to hold & I give &
will to my said wife one thousand dollars in
money to be one half in silver & the other half
out of a note I have on James H White.

I also will to my said wife Susan make five of
my Negroes &c, my Negro man Benjamin, my Negro
Woman Pat, my Negro woman & the my Negro
girl Hannah & my Negro boy Robert & all their
bedding & clothing they have also all my horses
& cattle, Hays, & Shup my Waggon & gear & all the
household & Kitchen furniture including my clock
& Loom to have & to hold. I also will my
Negro boy Isaac to my friend James H White
to have & to hold. I also will him the use &
profits of my upper meadow during my widow
widowhood then to go as the rest of that
plantation to Brother David, two children Wil-
liam & Mary. I also will to my Nephew William
Jenkins my Negro boy named Andrew to have & to
hold. I also will three hundred dollars to my
sister Margaret Shonberger to be paid to her by
my Executor at such time as he may think best
out of monies coming to me. The balance of
monies coming to me & Estate, The balance
of my Earnings & Estate I will to be equally
divided between my brother David, children
i.e., Margaret, William & Mary. I do
