James Haynes' Will

I James Haynes of the County of Lincoln & State of North Carolina being of sound ^{human} mind & memory and considering the uncertainty of life do this twenty first day of May Eighteen hundred & forty two make this my last will & testament in manner & form as follows

1st I desire after my death that all my just & lawful debt be paid -

2^d I give and bequeath unto my son Robert Haynes and my daughter Sophia Gault full title to all such property as they have already recd from me -

3^d I give and bequeath unto my wife Temperance Haynes all my right title interest and claim in two negroes named Rufus and Mary and their increase (which negroes are now in my possession) for the period of her life - and that after her death said negroes be sold and the money accruing from said sale from said be equally divided between all my Children viz - namely Robert, Sophia, Daniel, William, Newton, Susan, & Pelsera. provided however that my son Robert & my daughter Sophia have fifty dollars less than the rest of my Children of the proceeds of said sale, on account of what I have already done for them -

4th I will and bequeath unto my wife Temperance Haynes during her life the following property - viz all

my last will & testament in manner & form as follows

1st I desire after my death that all my just

2^d I give and bequeath unto my son Robert Hayes
and my daughter Sophia Gault full title to all such
property as they have already recd from me -

3^d I give and bequeath unto my wife Temperance
Haynes all my right title interest and claim in two
negroes named Rufus and Mary and their increase
(which negroes are now in my possession) for the
period of her life - and that after her death
said negroes be sold and the money accruing from
said sale from said be equally divided between
all my Children viz - namely Robert, Sophia, Daniel,
William, Newton, Susan, & Pelsera, provided however
that my son Robert & my daughter Sophia have
fifty dollars less than the rest of my children of the
proceeds of said sale, on account of what I have
already done for them -

4th I will and bequeath unto my wife Temperance
Haynes during her life the following property viz all
my household furniture - consisting of Beds - bedstead
& bedding furniture - one side board - one dresser - one
set of Windsor Chairs - one Candle Stand, Tables
& table furniture - also Kitchen furniture - Farming
utensils Books &c. and that the said property at the

death is to be sold and equally divided between all my children as named in the last bequest - provided however that my wife is to have full liberty in marriage of two youngest sons daughters Susan & Belsona to portion off to them of the above named property sufficient to give them a start in housekeeping and that such property shall be good unto so far as little is concerned

I ^{thly} I will and bequeath that my Darryall & Gigg be sold & that if the money derived from such sale be not to pay my debts - that it with all the funds that may be over and above the payment of my debts after collecting what money be due me at my decease be used as a fund for the support & education of my wife & two youngest daughters Susan & Belsona

6^{thly} And lastly

I hereby revoke and make null and void all my former Wills written by me, and I constitute and appoint Bartlett Shipp my lawful Executor of this my last Will & Testament - In Witness whereof I have hereunto set my hand affixed my seal This day and year above written
