John Singefelt's Will

In the name of God Amen I John Singefelt of the County of Lincoln and State of North Carolina Farmer being sick and weak in body but of perfect mind & memory thanks be given unto god calling unto mind the mortality of my body and knowing that it is appointed for all men once to die do make and ordain this my last will and testament that is to say principally and first of all I give and recommend my soul into the hands of almighty god that gave it and my body I recommend to the earth to be buried in a decent Christian埋葬 at discretion of my executors nothing doubting but at the general Resurrection I shall receive the same again by the mighty power of God and as touching such worldly estate wherewithal it has pleased god to help me in this life I give demise and dispose of in the following manner and form, 1<sup>st</sup> I give to my wife Rachel all the property that is on the plantation at the present time my black girl Judy & my black boy Chuck like also

give unto my beloved son John Gingerfield  
& Daniel Gingerfield my black boy Buck

 buy the claims from the other 3<sup>rd</sup> I give unto  
 my son David Singerfeld my black girl  
 Lucy after my son David Singerfeld pays  
 my daughter Sarah wife of Franklin House  
 One hundred and fifty dollars for her interest  
 in my black girl Lucy the balance of  
 my property is to be equally divided among  
 my sons and daughters without being  
 disposed of at Auction sale and if any  
 of the heirs of this my last will and Testament  
 will not Comply with the above conditions as  
 far as the property is not in this will mentioned  
 if either one of them wil not Comply with  
 the above shall forfeit their claims as far as  
 the distribution is interested 4<sup>th</sup> I give to  
 my beloved daughter Sarah wife of Franklin  
 House One hundred and fifty five dollars  
 out of the Estate as she got no land as the  
 boys all got Land and she got none 5<sup>th</sup> I  
 bequeath my son John Singerfeld and his  
 Rhyne the whole Executors of this my last will  
 and Testament and I do hereby utterly disallow  
 Revoke and Disavow all and Every other former  
 Testaments wills legacies Testests and Executors  
 of me in any wise before named wills and

My daughter Sarah wife of Franklin  
One hundred and fifty dollars for her interest  
in my black girl Lucy the balance of  
my property is to be equally divided among  
My sons and daughters without being  
disposed of at auction sale and if any  
of the heirs of this my last will and testament  
will not Comply with the above conditions as  
far as the property is not in this will mentioned  
if either one of them will not Comply with  
the above shall forfeit their claims as far as  
the distribution is interested & I give to  
My beloved daughter Sarah wife of Franklin  
Housen One hundred and fifty five dollars  
out of the Estate as she got no land as the  
boys all got Land and she got none of the  
Property my son John Singefeld and Eli  
Rhine the whole Executors of this my last will  
and Testament and I do hereby fully desollar  
Revoke and Disannull all and every other former  
Testament, wills legacies Testaments and Executors  
by me in any wise before named wills and  
Requeateth Ratifying and Confirming this and  
no other to my last will and Testament  
Ie witness whereof I have hereunto set my  
hand and seal this twenty fifth day of  
July one thousand Eight hundred and

fifty One, Signs sealed published  
pronounced and declared by the said  
John Penningfield as his last will and  
Testament in the presence of us who  
in his presence and in the presence of

have hereunto subscribed our names
