John Hayes' Will.

This my last Will and Testament —  
1<sup>st</sup> I Will to my son in law Doctor  
S. J. Harris in Alabama, two notes, which  
I hold on him nearly two thousand dollars,  
excepting five hundred dollars which I  
allow to be paid to my Estate. 2<sup>nd</sup> I  
Will to my son in law W<sup>m</sup>. Fulenwider  
not him but his Children, his wife & her  
Children that is with her at this time.

Also the landed property (including  
the ore bank) which I purchased at Sheriff's  
Sale, after the debt, which was sold for,  
with cost and Interest is paid up,  
then what ballance, remains, if any  
more or less, I Will to Fulenwider Children  
as aforesaid, that he the Said Fulenwider  
shall have no controul over said property.

3<sup>rd</sup> I Will to my son in law Charles  
L. Torrence Children, all the Negroes  
that I gave to my Daughter Elisabeth,  
and their increase —

4<sup>th</sup> I Will to my son in Alabama,  
five Negroes Fed, Jacob, Sila, and her two  
Children, Hannah & Anzi —

1<sup>st</sup> I Will to my Son in law Doctor

that I gave to my Daughter Elisabeth,  
and their increase —

4<sup>th</sup> I Will to my Son in Alabama,  
five Negroes Fed, Jacob, Sila, and her three  
Children, Hannah & Anzi —

5<sup>th</sup> I Will to my Daughter Marya-  
-rett, Five Negroes, Lima and two of her  
Children, Isaac and Henry, also Julia's  
two Children Laura & Harriet —

6<sup>th</sup> I Will to my son William. 5 Negroes, Silvester Bot, or Leander, Sally, Caroline & Anthony —

I have assigned away my <sup>wright</sup> to my son William two Negroes, Sophie & Tom, as Trustee or Guardian for my Grand daughter Catharine Minerva —

I now Will to my beloved wife the remainder of the Negroes not specified with all my lands in this County & in Mecklenburg with all my stock to be at her disposal, and all the other Negroes disposed of she is to have the whole control of them during her natural life, It is my Wish, that my son William, with the assistance of William Johnston, who at this time is my acting Agent, will give all the assistance to my dear Wife, in directing and helping to manage my Estate, and now I commit her with all my Family into the hands of the divine being who is able to direct, in all cases of emergencies is my sincere Prayer, and Gods Blessing rest upon them for Christs sake, Amen.
