Major Hull's Will

In the name God Amon. I Major Hull being of sound mind and memory blessed be God; I make this my last will and Testament as follows; I direct all my just debts to be paid. I give and bequeath to my beloved wife Peggy my negro girl Cirtha during her lifetime and her maintenance out of my plantations and mill during her single days.

3 I give and bequeath to my son William H. Hull all my river land on the North side of the River the river being the line.

4th I Give to my son H. H. Hull the balance on the South side of the River the River being the line.

5th My Will is that all my daughters Eliza, Sarah, Maryann, Peggy, Lovina and Rebecca E. Dealine shall all have an equal part that is to say Eliza the value of three hundred and fifty dollars; Sarah with what I have given her she shall have three hundred dollars more. Maryann shall receive three hundred and fifty dollars. Peggy Lovina shall receive three hundred and seventy dollars worth, Rebecca shall receive three hundred and seventy dollars in value. I give and bequeath to my wife Peggy her choice of one of my houses on mules and two cows and Calves her choice and six head of sheep, Eight

two cows and Calves her choice and six head of Sheep, Eight
head of Hogs her choice, I will have no grain because I give her a
mantainance off of my lands and Milk. My Will is that my son
G. W. Hull shall have in value three hundred dollars my Will is
that my Executor shall have it Stoley in his power to sell privately
or publicly any or all of my real & personally estate to pay
all my just debts and the balance if any be left. If any property
dont hold out to pay the sum of my daughter and son Marrying-
down it shall be added to them to make out the sum to them
heretofore Willed. I appoint, ordain and constitute my beloved
son William W. Hull Executor of this my last Will and Testament
And I disannul and disallow all other Wills and declare this
to be my last Will. Part of five lines beginning at the word
Should and ending at the word my that is pared out before
the signing of the same
