and admitted Record (viz)

In the name of God Amen, I Michael Mendenhall
Being of Sound Mind and Memory, Do hereby to
God, doth publish my last will & testament, that
fourth day of September in the Year of our Lord
One thousand Eight hundred & thirty seven, in
manner and form, First I give & bequeath unto
My Beloved wife Mandall my household & hold
in furniture, & three Cows her choice, & three
hogs, four Sheep, One Mare, named ^{by the} fly,
and two hundred Dollars in money, & likewise
the house where I now live in with all other buildings
including said house, & one Orchard her choice,
& one Meadow her choice, twenty acres of cleared
land her choice, & twenty acres of wood land
her choice, during her lifetime I will out of my
and I likewise give and bequeath unto my
two Sons John & Vile, undivided all the plantation
I now live on, to be equally divided at my wife's
death, so as Vile is to have the old improvement
including the dwelling house I now live in,
I also give unto my Daughter Sally three Cows &
One Sow, & pigs, One horse by the name of Caesar,
two Sheep, I also give unto my Daughter
Margaret three Cows, One Sow, & pigs, two Sheep,
and fifty Dollars in money, in the place of a horse.
I also give unto my daughter Elizabeth, three Cows
One Sow, and pigs, two Sheep and fifty Dollars
in money in place of a horse & cart.

And I also give Sixty acres of Land joining
 William Vickers, and Christiana Carter to my three
 Sons, Michael, Levi, Vile to be equally divided
 Between them, and likewise sixty acres of Land
 to be sold joining Michael Mahoney, Granted to
 Michael Carter by the State & I also give unto
 My Son Vile One Cow & half One Cow & pigs,
 One Mare, By the name of Ball, & his Saddle
 & Bridle. I also give unto my two Daughters
 Susannah, Margaret, forty Dollars in place of
 Saddle, and I also give unto Catherine Roberts
 Children Forty Dollars to be Divided Equally
 amongst them, I also give unto my wife Mary
 My Mill & all the Wood heads & the Balance
 of my property to be Sold by my Executors,
 to the highest bidder & be Equally Divided among
 my Children & wife, and I likewise constitute
 Make & Ordain my Son in Law David Crouse
 & my two Sons Jonas & John Radice to be
 Executors of this my last will and Testament
 In Witness whereof ~~I the said~~ I have hereunto
 Set my hand & affixed my Seal the day &
 year above written signed sealed & Delivered
