and memory sheweth to you, do this fourth day of July 1866 make
and publish this my last Will and Testament in manner & form

known as the home tract where I now live, containing by
estimation seventy five Acus. more or less, with all the woods
ways, mares and privileges thereunto belonging. Also all of the
balance of my Estate, Consisting of Stock Household & Kitchen
furniture to have and to hold at these above said Sarah Williams Executor
make and ordain my last Will and Testament, to settle up my Estate

make and ordain my beloved brother Wm. Williams Executor
of this my last Will and Testament, to settle up my Estate
