Catawba & State of North Carolina.

Considering the uncertainty of this life,
and being in perfect mind & memory,
(blessed be God) - do this first day of Decem-
ber in the year of our Lord One Thousand
Eight hundred and forty six, make and
publish this my last Will and Testament
in manner following. - First I will
my Body to be buried in a Christian
like manner, at the Expence of my
personal Estate. - 2nd I Will to my
Son David Huver my plantation whereon
I now live & for him to have possession after
my Death. The same Tract of land
lying and being in the County of
Catawba and State of North Carolina on
the waters of Howards Creek joining lands
of Henry Jones & others. - Beginning at a
Black oak Rudisills corner & runs with
Solomon Shamps line so 8 On 8. 109m poles
to a Red oak in the fork of a branch

with his line N. 19 E. 138 poles to a black oak
his corner, then N. 57 E. 3½ poles to Post Oak
a corner of land belonging to the Heirs of
Henry Bangel Deceased - Then with a line
of said land N. 27½ W. 20 poles to a black
Gum near a small branch. ~~Then~~^{then}
lines first S. 50 W 60 poles to a stake and

so long as my Daughter Elmira Haver
may live a single ^{life} and also to have

her support out of the Larder, willed to my son David Huner, so long as she may live a single life or continue to ^{live} with her Brother David Huner.

5th I Will that my son David Huner shall have the use of my horses, Wagon & farming utensils two years after my Death, provided he takes good care of the same, & keep the same in good order, and at the expiration of two years I will that the same property be left in the care of my son David Huner, be exposed to sale, with the balance of all my personal property, and the proceeds of the same be Equally divided between my three Daughters Malinda, Elmiry, & Sally.

6th I Will that my Daughter Elmiry shall have an equal portion with my two Daughters Malinda & Sally.

Say three head of cattle & kitchen furniture, which property is to be set apart for her, by my Executors.

7th I Will nominate and appoint Daniel Seigel Executor of this my Will and Testament and assigns and I do by these presents ratify & confirm publish and declare, this my last

I shall have the use of my horses, Waggon & farming utensils two years after my death, provided he takes good care of the same, & keep the same in good order, and at the expiration of two years I will that the same property be left in the care of my son David Humer, be exposed to sale, with the balance of all my personal property, and the proceeds of the same be Equally Divided between my three Daughters Malinda, Elmiry, & Sally.

6th I Will that my Daughters Elmiry shall have an equal portion with my two Daughters Malinda & Sally.
