

Item, I Give to my son Edmondson Smithwick a Small Tract of Land on the west Side of the River but containing fifty acres more or less to him and his heirs forever.  
Item, I Give and bequeath unto my Grand Son Edmund Blount all that Tract of Land below Scopemong River that did formerly belong to James Turnbull Deceased which I Bought of Yandue. Item, I Give to my Son Edmondson Smithwick a Tract of Land I Bought of James Barton.  
Item, I Give to my Daughter Mary Carkel three acres of Coquina with the ware House on Gardner Creek during her Continuance on the said Land.  
Item, I Give to my Daughter Mary Carkel one Small Bay Horse one Feather Bed and Chest three Chairs and one Table for the Term aforesaid.  
Item, I Give to my Daughter Mary Carkel Ten Shillings Sterling money of Great Britain to be paid to her out of my Estate. Item, I Give to my son Edmondson Smithwick all my Houses Gardens and Washing Tubs together with all the other things on the plantation that is not already given in this my will. Item, I Give to my son Edmondson Smithwick a Tract of Land on the Eagle Swamp containing one Hundred acres more or less to him and his heirs forever. Item, I Give and Bequeath unto my Son Edmondson Smithwick all my Stock of Horses that is not already given Except one mare valuable to Ten pounds, prov. money to him the said Edmondson and his heirs forever.  
Item, I Give to my Beloved Daughter Africa Blount one Riding man worth Ten pounds prov. money.  
Item, Whereas I have a Debt for the Land whereon Isaac Gardner now lives as surety for the sum of Forty Two pounds, with Interest my will is that he may have one year to pay the Debt and on his failure for the Land to be sold for the most that can be had to pay the Debt and the overflow of the money be returned to him the said Isaac Gardner. Item, I Give to my Son Edmondson John Smithwick a Tract of Land known by the name of the Pine Log Compur containing one Hundred and twenty acres

to him and his heirs forever. Item, I Give to my Daughter Mary Carkel one Cow and Calf as above said. Item, I Give to my Son Edmondson Smithwick all my stock of Cattle Hogg and Sheep that is not already mentioned in this will. Item, my will is that all my outstanding Debt that is justly due be collected to pay Debt lastly due from me since the act of certain deeds of Gifts made to my four sons and the remainder of the outstanding Debt be equally divided between my four sons. Item, I Ratify and confirm certain Conveyances of certain Negroes made to my four Sons Edward John Samuel, and Edmondson Smithwick, they conforming with the conditions of such Conveyances. Item, I will that all the Residue of my Estate as well real as personal be Equally divided between my four Sons above named that is not mentioned in this my last will and Testament and I do appoint my four sons (viz) Edmondson Edward Smithwick Edmondson John Smithwick Edmondson Samuel Smithwick and Edmondson Smithwick Executor of this my last will and Testament utterly revoking and making null and void all other and former will or wills by me heretofore made willed or Bequeathed (ratifying) this to be my last will and Testament In witness whereof I the said Edmondson Smithwick have hereunto set my hand and seal the day and year first above written pronounced published and declared by the said Edmondson Smithwick as his last will and Testament In the presence of us
