publish and declare this to be my last will and testament hereby revoking
all others in manner and form following To wit

Concho Creek said tract is more particularly described in a deed
from Joshua Taylor to me the condition of this gift of the foregoing
land is to pay to my sister Arlinda Stevenson the sum of Four
hundred dollars which I justly owe her and provided she receives
the same in payment and in case she refuses to accept the same on
the foregoing conditions it is my will and desire that my executors
herein after named shall sell the said tract of land and pay
the said amount out of the proceeds of such sale

Item 2- I lend to my sister Arlinda Stevenson during her
natural life my home tract of land and at her death I give the
said land unto her children George and Willie and their heirs
forever Provided and with the distinct condition that my mother
Elizabeth Purvis shall have and claim a home at my house
and upon my home tract during her natural life if she desire
it

Item third 3- I give all my stock of cattle to my sister Arlinda
Stevenson

Item 4th I give unto my sister Laura Purvis my gold watch &
chain

Item 5th I give unto my sister Ocellar Purvis one gold chain

Item 6th I give unto my Bro W. W. Purvis my double barreled gun
and walking cane

Item 7th All the residue of my estate of every description
notes accounts debts in action or possession I leave for my executor
hereinafter named to collect and sell or so dispose of as he may
think best for the interest of my estate and heirs

Item I lend to my beloved daughter Sendarilla Satterwhite certain tract or parcel of land lying and being in Martin County and State of North Carolina situated on an Horses branch

adjoining the land of Messrs Harrell and Wm. L. Bowen, being beginning on the branch where the road crosses the branch running north 28 west 4 poles thence along the thence along the south 28 west 60 poles thence north 22 east to Harrells line thence south 60 east to the run of Spence branch thence down the various courses of said branch to the first station containing by estimation fifty acres more or less and give it to her children if any If no children I wish it to return to my lawful heirs

Item I lend to my beloved daughter Ann Eliza Harrell a certain tract or parcel of land lying and being in Martin County and State of North Carolina situated as follows Beginning where the road crosses Spence branch adjoining the heirs of L.
