I George Goddard of the State of North Carolina and County of Johnston being of sound and perfect mind and memory, (blessed be God for the same) do this 22nd day of October in the year of our Lord one thousand eight hundred and twenty four make and publish this my last will and testament in manner following; that is to say first I give and bequeath my negro man Moses to my four children namely Mariah Outenbridge Elizabeth Outenbridge Joseph Outenbridge & Sarah Outenbridge to be equally divided when Sarah Outenbridge becomes of age of twenty one year. Item I give and bequeath following negroes namely Fanny Dinah Mary Moses & Sam in form and manner following to be equally divided between Mariah Outenbridge Elizabeth Outenbridge Sarah Outenbridge and Stephen Outenbridge to be equally divided between when Sarah Outenbridge becomes the age of twenty one year. Item I give to my son Joseph one hundred and thirty by me and ordain my worthy friend Leavelling Bowers Executor of this my last will and testament. In testimony whereof I the said Drusilla Outenbridge have to this my last will and testament set my hand and seal the day and year above written.
