

In the name of God amen I Stops Council of the Society of separation in the State of South Carolina being very weak in body but of sound and disposing mind and memory and willing to spend the materials of manhood and knowing that it is appointed for all men once to die as made and ordain this my last Will and Testament in manner and form following first and principally I recommend my Soul into the hands of Almighty God that gave it and my body to be buried in a decent Christian like manner at the Direction of my Executors Vrs I wish that Just Debts and funeral Charges be paid and Satisfied out of my Estate I bequeath to my beloved Wife Livia Lovell the Land and Plantation whereon I now live and the land and Plantation on the Little creek and my Negro man Stops and my Negro girls Scandy and Sambo and all my home hold and Kitchen furniture and Plantation utensils and all my Stock of Hock and my ware and Cott and all my Stock of Hogs & Cattle During her Natural life or Widowhood and then to return to whom it shall be hereafter given - I then I give and bequeath to my Son Simon I Lovell the Land and Plantation whereon I now live and the land and Plantation on the Little creek the Land and Plantation on the Little creek he is to receive when he arrives to the age of twenty one year and my young son Joseph my feather bed and furniture and my hunting Gun to him his heirs and assigns forever I then I give and bequeath to my Daughters Polly Lovell Crispa Lovell Polly Lovell and Melley Lovell Each of them one feather bed and furniture to them their heirs and assigns forever I then I give and bequeath to my four Daughters Polly Lovell Crispa Lovell Polly Lovell and Melley Lovell one hundred acres of land or Office Spanish and my Coopers tools to be sold and Equally Divided between them and my blacksmith tools to be hired out yearly till my Son Simon Lovell arrives to the age of twenty one year for the use of the family and then to be sold and Equally Divided among all my Son living Children I then I give and bequeath to my four Daughters Polly Lovell Crispa Lovell Polly Lovell and Melley Lovell my two Negro Negro girls Scandy & Sambo to be Equally Divided between them their heirs and assigns forever Lastly I Comitate and appoint John Readick Esq and Wash Readick Executors to this my last Will and Testament hereby revoking and annulling all former wills by me made and Ratifying and Confirming this and no other to be my last Will and Testament in Witness Whereof I have hereunto set my hand & Seal this 30<sup>th</sup> day of June 1813

19 In the Name of God Amen I Phoebe Ashner of the State of North Carolina and County of Johnston this the nineteenth day of July in the year of our Lord one thousand Eight Hundred and thirteen do make and declare this my last will and Testament and last of all I give my soul to God who gave it me and my body I recommend to the Earth to be buried in a Christian like manner at the discretion of my Executors and as touching those worldly goods I hath pleased God to bless me with in this world I give devise and suppose off in the following manner and form Item I give to Allen Ashner one sixth of land against Thomas families due July Eighteen hundred & thirteen also one young mare at my death to him and his heirs forever Item I give to Patsy Clapham at my death all the Residue of my Estate Real or Personal both within & without to her and her heirs forever And I Elect & chose William Byggs Esq. as Executor to this my last will & Testament Ratifying & Confirming this & no other to be my last will & Testament in Confirmation of which I Phoebe Ashner have hereunto set my hand & affixed my seal The day and date above written Signed Sealed and declared by ~~Phoebe~~ Ashner to be her last will & Testament in Presence
