Item - I give and Bequeath to my grand Daughter Susanah Hyman twenty Dollars to her and her heirs forever -

Item - I give and Bequeath to my son Henry Hyman twenty Dollars to him and his heirs forever - It is further my will and desire that all my Property that I have not given away to be sold and after paying my last debts the Balance of the money arising therefrom to be equally divided between my three Daughters Fanny Hyman Sally Hyman and Sabrina Hyman to them and their heirs and assigns forever -

And I hereby make and ordain my worthy friend Hendrick Taylor my executor of this my last will and testament in writing whereof I the said Susanah Hyman have to this my last will and testament set my hand and seal the day and year above written - Signed sealed published and witnessed in presence of us
