whereon I now live viz beginning at the Lightwood log Branch thence the Course of my crop fence to the back line - thence along my own line the various courses to the beginning so as include the House wherein I now live with all the privileges thereunto belonging and all my stock of Hogs - one Cow & calf - four Cows & Lambs - four Beds & Churns - all my Plantation utensils - All my House hold and Kitchen furniture - one Horse her Chaise - It is my Will and desire that if the last property that I have lent to my dear beloved Wife should die or wear so that she could not make support out of the balance of my Estate during her natural life -

Item - It is my Will and desire that if the Negro Woman Labra that I have lent to my dear beloved Wife Elizabeth Daniel shall hereafter have any increase of her body that the said increase shall belong to my said Wife to her and her Heirs forever -

Item - I give and bequeath unto my two Sons in Law David Latham and Harry Latham ten Dollars each to be raised out of my Estate to them and their Heirs forever -

Item - I give and bequeath unto my son in Law David Latham one Negro man named Wilson to him and his Heirs forever -

Item - I give and bequeath unto my Daughter Mary D. Wheatly one Negro Man named Xasin to her and her Heirs forever -

Item - I give and bequeath unto my three Daughters viz Lewisa Jewell Mary D. Wheatly and Charity Latham the following Negroes viz Jeph Dampsey - Ester Cook - Midge - Redy - Dinah and Lydia to them and their Heirs forever -

Item - I give and bequeath after the death of my beloved Wife Elizabeth Daniel the following Negroes to my three Daughters viz Lewisa Jewell Mary D. Wheatly and Charity Latham - Jude Tabny and Stephen to them and their Heirs forever -

Item - It is my Will and desire that all my Lands shall be sold also my Mill on a credit of twelve Months and the money and profits arising from the sale of the same to be equally divided between my three Daughters Lewisa Jewell Mary D. Wheatly and Charity Latham to them and their Heirs forever -

Item - It is my Will and desire that my Wife shall have all of her grain ground to be free at my Will also to have all her Cotton picked to be free during her natural life

Item - It is my Will and desire that all my property that I have not given away nor disposed of heretofore shall be equally divided between my three Daughters Lewisa Jewell Mary D. Wheatly and Charity Latham to them and their Heirs forever -

And by I do constitute and appoint my Son in Law David Latham

And Lawrence Cherry Executors to this my last Will and Testament hereby revoking and disannulling all former Wills by me made and ratifying and confirming this and no other to be my last Will and Testament in Witness whereof I have hereunto set my hand and seal this 13 day of January 1830

In the name of God Amen - Know all men by these presents that I William Robason of the above mentioned County being in a low state of health and calling to mind the Infirmary of the body and knowing that it was appointed for all men to die do make and ordain this to be my last Will and Testament in manner and form following (namely)

First and principally I commend my soul into the hands of Almighty God that gave it and my body to be decently buried at the discretion of my Executors and as touching such worldly goods as it has been pleased God to bless me with. I will ~~give~~ give in name and form following that is to say I lend to my well beloved Wife Betty all my Land and plantation and likewise all my property both within doors and without (except paying my just debts) during her life term or widowhood and then to be divided between my two Children Penley and Harry - likewise I nominate and appoint Luke McGill to be my Executor this 15th September 1826
