" In the name of God Amen. I Robert Morrison Miller of the County of Bucks
State of Pa^e being very sick & weak in body but of perfect mind
& memory make this my last will & Testament. That it may
most truly & truly be known that it is my will for all manner
to die, & pass away & be buried in this my last will & Testament. That it may
first & principally my earnest desire & intent that my soul into the hands of Almighty
God that gave it & my body be committed to the earth to be
buried in a decent Christian burial at the discretion of my
executors making distribution at the general resurrection
I shall receive the same again by the Almighty power of God.
And as touching such worldly estate wherewith it has pleased God
to trust me upon me in this life, I give & devise & dispose of the same
in the following manner & form—First. I will that all my just debts
be paid together with all my funeral charges. Item I give & bequeath
my savings since Abraham Miller my plantation whereon I now live
containing two hundred & acres of land Item I leave unto my wife
Jennett Miller my clock bay mare & one cow & bullock, one bid & one
bullock, one chest & basket of the household furniture & other things
proper to keep together with her living on the land during her Ma-
ternal life. Item I leave unto Sarah Wallace one cow. Item I leave
five silver dollars to support the gospel in Discipella Church
Item I will that my body be interred with the substance
of the last of creation, & such of the household furniture, as my
wife does not think proper to keep is to be sold & the money arising
therefrom with my notes & books etc to be apportioned to her
in clearing her maternal life, and after her decease if any thing
should remain to be equally divided among my children.
I name & call Abraham Morrison & his wife with the assistance
of James McPherson & witness of this my last will & Testament
William Miller, Abraham Miller, Elizabeth Reed, Jennett
McRee, & Martha McRee & the hereby revoking all
former wills & testaments made all former wills, Testaments or

Sacred to the service of God, given, Granted, Appointed, Consecrated
to be observed, & Observed, Year ensuing this & this truly to be my last
will & Testament; the Testimony whereof I have hereunto set my
hand & seal this 2^d day of January in the year of our Lord 1804.

years, & that all or so much of my personal estate shall remain
in the hands of my wife Piggy during said term of fifteen years
as my executors may judge sufficient, not to render
her the & her children said children viz Hannah, Samey, Piggy L,
James D, Robert & Billy & Thomas. And it is further my will &
