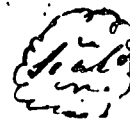

22 In the name of God Amen. I Abraham Miller of the County of Beaufort
State of S^c Carolina, being very sick & weak in body but of perfect mind
& memory thanks be given to Almighty God calling into mind the
Mortality of my body & knowing that it is appointed for all men once
to die, Do make & declare this my last will & Testament, That into my
first & principally, I recommend my soul into the hands of Almighty
God that gives it & my body I recommend to the earth to be
buried in a decent Christian burial at the discretion of my
Executors no thing doubting but at the general resurrection
I shall receive the same again by the Almighty power of God.
And as touching such worldly Estate wherewith it has pleased God
to bestow upon me in this life, I give Devise & dispose of the same
in the following manner & form—First I Will that all my just debts
be paid together with all my funeral charges. Then I give & bequeath
my loving son Abraham Miller my plantation wherewith now lies
containing two hundred acres of Land. Then I leave unto my wife
Jennett Miller my black boy man & one cow & calf, one bed and
bedding, one Chest & such of the household furniture as she thinks
proper to keep together with her living on the land during her Na-
tural life. Then I leave unto Sarah Wallace one Cow. Then I leave
five silver shillings to support the Gospel in Deepella Church
Then I Will that my body be laid out with the ballance
of the State of Carolina & such of the household furniture, as my
wife does not think proper to keep is to be sold & the money arising
therefrom with my notes & book debts to be appropriated to her
use during her Natural life, and after her decease if any thing
should remain to be equally divided among my Children.
James Miller whom I constitute & declare with the Assistance
of James Melkinson Executors of this my last will & Testament
William Miller, Abraham Miller, Elizabeth Reed, Jennett
McRee, & Catherine Smith the be her day seeing dis-
posed of, & making void all former wills, Testaments &c

Exclosures heretofore made, Given, Granted, Appointed, Constated
to be done, Ac. Tying & confirming this & this only to be my last
will & Testament. In Witness whereof I have hereunto set my
hand & seal this 26th day of January in the Year of our Lord 1804

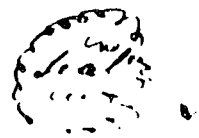

in the State of New York being in a sickly & frail state of body, but of
sound mind & memory thanks to God therefore, calling to mind the
mortality of my body & approaching dissolution, Do make &
Declare this my last will & Testament viz principally & first of all
I give my soul into the hands of Almighty God who gave it
& my dying body I recommend to the earth to be buried in
a decent manner at the discretion of my executors not doubt-
ing but I shall receive the same again at the general Resurrection

in the hands of my wife Peggy during said term of fifteen years
as my Executors may judge sufficient to maintain her to receive
along with the said Children viz Hannah, Samy, Peggy L,
James D, Robert & Billy & Thomas. And it is further my will &
