In witness, I will that all my just debts be paid by my executors hereafter named - Secondly, I will & allow my beloved son Robert Wilson to have fifteen dollars out of note of hand which he has in his possession, pay able to me from Sarah Allen & Joseph Blackwood Esq; for the sum of Sixty dollars, as a compensation for the trouble I have been to him in this my illness Thirdly I will & allow my beloved daughter Anna Tuckel all my Books & miniature of every kind, all my clothes, my Beeswaxer, & every article of household & kitchen furniture, also all my bedding & rags to be for her use & at her disposal. Fourthly I will & allow my beloved son John Wilson to have Twenty dollars out of the above mentioned note now in the possession of my son Robert Wilson & due to me from Sarah Allen & Joseph Blackwood Esq; which said Twenty dollars I allow to be paid to Interest to Interest & the note remaind unpaid once every year, to said Twenty dollars & the interest arising from it be paid to him by my executors hereunto to be named when he arrives at the age of twenty one

Fifthly I will & allow the balance due on the above mentioned
notes after paying off the two above mentioned legacies together
with about forty dollars due me from Thomas Henry be
applied to the payment of my debts & if there should be
any surplus money after the payment of my debts as
aforesaid I will & allow it to be paid to my Daughter
Anna Todd by my Executor hereafter to be named -

Sixthly I do hereby Ordain, Appoint & constitute my trusty
friend William Gleason Esq. my whole & sole Executor of
this my last Will & Testament, hereby revoking and
disannulling all former & other wills, making & Appointing
this & this only as my last Will & Testament
