three Children Abraham, Polly & John. — 4th It is my will
& desire that my after named Executors should bind out my
two sons Abraham & John to learn some good Trade
5th I hereby appoint my friends Job. Henson & William
Lecton Executors to this my last Will, In Testimony whereof
I have set my hand & seal this 12th day of January 1816

In the name of God Amen. I Charles Fisher of the Waxhams
Hicklenburg County & State of N^o Carolina, being at present
weak in body, but of a sound & disposing memory & understand-
ing, & calling to mind the uncertainty of this life, and that it is
appointed for all men once to die; Do make & declare this my
last Will & Testament in manner & form following, Principally
and first I do recommend my soul into the hands of God my Savior
who gave it & bought it, and my body I resign to the earth, there
to rest till the morning of the resurrection when Christ will
destroy death & redeem my body from the grave, and in my flesh
I shall see God in hope of which I desire to be buried in a Christian
like & decent manner at the direction of my Executors herein
after named; and as touching such worldly estate wherewith I have
pleased God to bless in this life, I give & dispose of the same in the man-
ner & form following. — First I Will that all my just debts, so
far as charges be paid & discharged as soon as conveniently
may be after my Decease. — Then I Will & bequeath as much as
will to my son William Fisher a note on David Greenhouse for

Eighty three dollars principal which I consider as justly due him for services which he did for me after he came of age - I have given and begun with or make over to the children of Paul Fisher Deceased the plantation on which I now live with all the improvements thereto belonging, being the fulfilment of my promise made to him when I borrowed some money from him about the time I first took up the Land and then Hunt or assigns for me - Item It is my will that all the rest of my land, also my negro fellow Harry & likewise all my other property in the House or in the farm be sold Except my negro woman Dick & her three children Diner, Diner & Abner in respect of these my will is that they be be valued by two Magistrates & three free holders and be kept in the families of William Fisher Frederick Starns and Paul Fisher Deceased - Item It is my will that all the monies arising from the sale of Land or other property or from collecting in outstanding debts to gether with the amount of the valuation of the negroes be divided into five equal shares (Except as herein after excepted) & given to my children viz one share to the children of John Fisher Deceased one share to Frederick ~~Starns~~ Fisher one share to William Fisher, one to the children of Paul Fisher deceased and last share to Mary Starns - Item I do hereby charge John Fisher Deceased and Frederick Starns with one hundred Dollars each to be deducted from their respective shares and equally divided - They each of them having received value for that sum out of the price of a tract of Land sold for me on Holstein river which they agreed at the time to acknowledge as part of their shares in the last division -

And lastly I hereby nominate constitute & appoint my son William Fisher & my son in law Frederick Starns to be the entire executors of this my last will & testament, hereby revoking all former wills by me heretofore made, In witness whereof I have hereunto set my hand & seal this first day of June in the year of our Lord 1814 -
