 them to be valued in its natural state, also all the rest of my  
 sons by name, Hugh Leary, George W Leary James Leary &  
 Jackson Leary shall be made equal with the two other proper  
 with my two sons William W Leary & Ewan Leary, It is also my  
 wish that my wife Esther Leary shall have all my household  
 & kitchen furniture during her natural life or widowhood  
 then the same property to be equally divided between  
 lawful heirs, and after my just debts & funeral expen

is my will that the fullness of my property be  
 Equally divided betwixt my daughter by name Esther Leary  
 Davy Leary, & Nancy Leary, & Elizabeth Leary & Emity Leary  
 And I hereby make & Ordain my beloved wife Esther Leary Exec<sup>tr</sup>  
 also my sons William B Leary & Esau Leary Executors of this my  
 last Will & Testament the Witnesses to hereof I the said George

32 In the name of God Amen. I have been long in a sick & weak condition  
 tho' of perfect mind & memory, yet calling to mind the mortality of my  
 body, & that it is appointed for all men to die, do make & Ordain  
 this to be my last Will & Testament, and in the first place I resign my  
 body to the grave, and my soul to God who gave it, my body to be  
 buried decently according to the Discretion of my Executors  
 and in the next place, I will & charge that all my lawfull debts  
 be punctually paid, together with my funeral expenses -  
Item I charge that unto my son William be one bed & furniture  
 together with the my increase - Item I charge that all the other  
 property of ~~which~~ I have possessed (except my land) to be sold & the  
 money paid to interest for my son William, the land to be kept for  
 my son William, any residue debts due to me to be managed for

 & Testament, & I do hereby disclaim & utterly deny all other Wills & Testaments  
 and do declare this to be my last Will & Testament - Given under my
