-ner, first I declare in my will That all my legiti-

hard money, And to my step daughter Elizabeth Smith
the like sum of five pounds & to my step Daughter
Catherine Smith the like sum of five pounds of hard
money. And to my own Daughter Mary Agnes I give all
the remainder of my Estate after my wife Mary Appoline
has drawn her third of all my Estate & all this shall
be done after my decease; And I do nominate & appoint
my beloved son in law Jacob Miller to be my
Executor of this my last will & Testament, & I do
declare this only to be my last will & Testament &
hereby revoking all others by me heretofore made
in Writing whereof I the said George Lower the testator
have hereunto set my hand & seal this first day of
June in the Year of our Lord 1725.
