And it is my desire that my wife shall pay all my debts. And I do hereby constitute & appoint my two sons William & Matthew my sole executors to this my last will & Testament, disavowing all other former wills, Ratifying this & no other to be my last will & Testament in witness whereof the said Matthew Mallam hath hereunto set his hand & affixed his seal this 26th day of May in the year of our Lord 1824. - Signed sealed & delivered to be his last will & Testament in the presence of us who in the presence of each other his executors affixed our names as witnesses.
