 memory calling to mind the Mortality of my Age & body ready
 knowing all men must die & after death be called to judgment
 And as something seeme worthy title as Good hath blessed me
 in this life I Will give & dispose of the same in the following manner
 I will give to my selfe & sonny to Joseph Thompson my
 beloved son all that part of my Land which lies on the north side
 of your Creek flowing on the border betweene Johnstones & Hens
 sons land & is bounded about 100 acres more or less to him & his Heirs
 & assigns, also I take my Negro boy named George to him the said
 Joseph his Heirs & assigns, moreover likewise one Negroe, four Dogs to
 him the said Joseph his Heirs & assigns, moreover then I will give to my
 Slavery in my beloved son Gideon Thompson all the remainder of
 my two tracts of Land that is the two large tracts which lies south of
 your Creek abounding sand & stone as it now appears to be the
 dividing line betweene said Joseph & said Gideon to him the said
 Gideon his Heirs & assigns forever & give likewise to the said
 Gideon one Negro woman named Venus, one large peecie dish ha chaine
 all the dishes in my house at my death, likewise my Spice Box &
 one large Stone long Way feather bed & bedding to her Heirs &
 assigns forever - Then I give to my beloved daughter Mary Carlton
 one bed Quilt & the sum of five Shillings - Then I give to her
 to my beloved Daughter Elizabeth Blackwood one Negro boy named Jack
 to her during her natural life & at her death it is my will that
 said Negro boy be sold by my executors for the best price can be got
 & divided among all her Heirs that is the said poor Blackwood poor
 widow leaving both to them their Heirs & assigns forever Then I give
 to my beloved ~~Daughter~~ Negro boy the sum of five Pounds
 to her & assigns, one Peecie dish & the sum of five Pounds
 Then I give to my beloved Grand Daughter (Daughter
 of the above) the sum of five pounds This is the last of my testa

in this life I Will give & bequeath to my son in the following manner
I will give bequeath capes off & country to Joseph Thompson my
beloved son all that part of my land which lies on the north side
of your creek flowing on the border between New Hampshire & New
England. It lyeth about 100 acres more or less to him & his Heirs
& assigns, also I bequeath to my Negro boy named George to him the said
Joseph his Heirs & assigns, two Negroe libraries one large, & one fine Doge &
him the said Joseph his Heirs & assigns, for ever. Item I Will give, bequeath
& leave to my beloved son Gideon Thompson all the remainder of
my land & parts of land that is the law being granted to him. his sonth of
your Creek abutting said Creek as it now stands to be the
dividing line between said Joseph & said Gideon. to him the said
Gideon his Heirs & assigns forever, & give likewise to the said
Gideon one Negroe woman named Well the Negro boy named Dick
& the same one large Pewter Dicke to him his Heirs & assigns forever.
Item I give & bequeath to my beloved Daughter Jane Blackwood
one Negro woman named Ursula, one large Pewter dish her chaine
all the dishes in my house at my death, likewise my Spice Box &
one large Stone Corp. my feather bed & bedding to her other Heirs &
assigns forever. Item I give to my beloved daughter Mary Carlton
one bed Quilt & the sum of five Shillings — Item I give & bequeath
to my beloved Daughter Elizabeth Bradshaw one Negro boy named
Dick to her Heirs & assigns forever. Item I give & bequeath to my
beloved daughter Jane Blackwood one Negro boy named Jack
to her during her natural life & at her death it is my will that
said Negro boy be sold by my executors for the best price can be got
& divided among all her Heirs that is the said Jane Blackwood leaving
dividing children to them their Heirs & assigns, for ever. Item I give &
bequeath to my beloved Daughter Anne Bradshaw one further
Heirs & assigns, one Pewter dish & the sum of five Shillings
Item I give & bequeath to my beloved Grand Daughter (Daughter
of James Thompson) the sum of Five pounds. This is to be my last
Will & Testament that all the remaining part of my Estate that is not left
among other persons my heirs & assigns & all my last debts to be paid
divided among all my surviving children she & those children

And Lastly I hereby nominate & appoint my son in law James Richardson & my beloved son Gideon Thompson to be my whole Heirs executors of this my last will & Testament hereby revoking all former writing, Gifts, Legacies &c begun & unexecuted, whether in word or writing, Ratifying & confirming this & no other to be last will & Testament. In witness whereof I have set my hand seal this 2d day of May 1796.

his full share. 7^o I leave to my son Hugh Todd. One pound
deth completing their full share. 8^o I leave ten shillings
to my son John Todd it completing his full share. 9^o I leave
ten shillings to my son Adam Todd it completing his
full share. 10^o I leave ten shillings to my daughter Polly
Todd it completing her full share. 11^o I leave ten shillings
to my daughter Hannah Coopster it completing her full share
12^o I do hereby disallow & disannul & revoke all other wills
& testaments made by me before this date.
