manner following by my Executors here after named —

interred in the earth in a decent manner of Christian burial  
at the discretion of my Executors after my death —

& be the sole Executor of all my personal Estate & that my Daughters  
Elizabeth, Sarah, Rebecca, Martha & Margaret be given a allowed  
each of them as much out of my personal Estate as will be a  
share equal to one of those that my Married Children receive.

hand or possession of a reasonable estate after her decease shall be  
given or come to my son John.

I Give & bequeath to my son John Ford all my lands or real estate  
by him to be possessed & enjoyed for ever after the decease of  
his mother or clearing his her inheritance. And I do further resolve  
& declare all wills or testaments by me made and I do  
constitute & appoint my wife Rebecca Ford & Jacob Selfe to be  
executors of this my last will & Testament, as witness my hand  
the first day of June 1783

David Henrich except my body clothes which I allow to be  
equally divided to my Daughters Mary & Esther demand and  
Sarah Trumble, I also give ten shillings to my son James & like  
wise ten shillings to my grand son James Henrich, I also leave  
to my daughter Sarah Trumble my side saddle, I do constitute
