In the name of God Amen. I James Fairies of the County of Meck-
lenburg & State of N. Carolina, being sick & weak in body, but of
perfect sound mind & memory (blessed be God for his mercy!) Do hereby make
Constitute & Ordain this my last will & Testament in manner &
form following; Revoking & making void all former wills, legacies
& bequests by me heretofore made or written.

Interpunct. I will & bequeath to my Brother John Fairies all & singular
my whole estate real & personal of whatever kind or denomination
it may be, upon the express conditions herein after mentioned Viz
1st That he pay to my Sister Mary Wright the sum of fifty pounds Sterling
which is to be divided among her children at her death as she thinks
proper — 2nd That my Brother John pay to my Sister Mary Deaquer
the Interest of one thousand Dollars during her life & at her death
the aforesaid one thousand dollars be equally divided between
her two children, & if either of said children should die before
the age of 21 or become bankrupt &c. Then the aforesaid one
thousand Dollars shall be paid to the survivor, & if both
should die, then the aforesaid one thousand Dollars shall be
divided among my relations at the discretion of my Executors
3rd That my Executor pay to my Brother William Fairies the sum of
three thousand Dollars as soon as it can be collected out of the
debts due to me in the County of Mecklenburg &c.

32 4th. That my Executor pay to Alexander Wilson fifty pounds Sterling
I also that he pay to each of his children by my sister Jane (nee Mary)
John & Alexander the sum of fifty pounds Sterling — Lastly all the
remainder of my Estate after paying the aforesaid Legacies & all my just
Debts I will to my brother John Fairies his Heirs and Assigns forever
And I do hereby constitute & appoint my brother John Fairies whole
& Sole Executor of this my last Will & Testament with full power and
Authority to Execute the same in the manner he may deem most
to the advantage of my estate — In Witness whereof I have hereunto
set my hand & affixed my Seal the 2^d day of May 1808 and in

I may die possessed of all my Goods, & Chattels, bonds notes Accounts
debts of every description of effects I may die possessed of or
that might or may be recovered in any Court of Law or Equity
for me or in my name or on my account share & share alike
constituting them their Heirs & Assigns the whole & Sole Heirs
of my estate after discharging my just debts & the above beque-
-athments — I hereby constitute nominate & appoint
my Trusty friend William Beane the elder & Joseph McKeithen
to be my Executors to this my last Will & Testament, hereby
declaring, publishing & pronouncing this to be my last &
sole Will & Testament & disannulling all others, In Witness
