it may be, upon the express conditions herein after mentioned Viz
1^o That he pay to my Sister Mary Bright the sum of Fifty pounds sterling
which is to be divided among her children at her death as she thinks
proper - 2^o That my Brother John pay to my Sister Anna Drayton
the interest of one thousand Dollars during her life & after death
the aforesaid one thousand dollars be equally divided between
her two children & if either of said children should die before
the age of five or seven years old issues, then the aforesaid one
thousand Dollars shall be paid to the survivor, If both
should die, then the aforesaid one thousand Dollars shall be
divided among my relations at the discretion of my executors
3^o That my Executor pay to my Brother William Fair, the sum of
one thousand Dollars as soon as it can be collected out of the
debts due to me in the County of Mecklenburg -

32 4th. That my Executor pay to Catherine Wilson fifty pounds Sterling
& also that he pay to each of his children by my sister Jane Mary &
John Fairs under the sum of fifty pounds Sterling — Lastly all the
remainder of my Estate after paying the aforesaid legacies & all my just
Debts I leave to my brother John Fairs his Heirs and Assigns forever
Ande I do hereby constitute & appoint my brother John Fairs whole
& sole Executor of this my last Will & Testament with full power and
Authority to execute the same in the maner he may deeme most
to the advantage of my estate In witness whereof I have hereunto set
