" In the name of God Amen. I James Finley of Mecklenburg
County, being at present sick & weak in body, but of a sound &
disposing mind & memory blessed be God, & calling to mind the mor-
tality of the body & that it is appointed for all men once to die
do make & ordain this my last Will & testament in manner & form
following Viz First of all I recommend my soul to God who gave it
& my body to the earth to be buried in a Christian like and decent
manner at the discretion of my executors herein after named
& as touching such worldly estate as it hath pleased God to blesse
me in this life I give & dispose of the same as follows
First I will that my just debts be paid & discharged as soon as
convenient after my decease. Afterwards I give & bequeath unto
my son William a part of the land I now live on to be had of to
him in the following manner Viz Beginning on my line where
it crosses the road leading from my house to the house of John
Gordon & runs S. 45° E. 45 feet to a Hickory tree N. 55° E. with
Pearson McPherson's old line crossing the creek to a Hickory McPherson's
corner, thence N. 45° W. 54 poles to a red oak, said McPherson's corner
thence to the corner of my said tract to said McPherson's, thence with
the side of said field to a lick by the creek, thence crossing said
creek & up the side of the said bank to the mouth of a small branch
thence up the various meanders of the said branch to the aforesaid
road, thence to the beginning, supposed to be about 1/2 a mile
in the same line or less and his heirs in jactiope -
Item. I will & bequeath to my son in law Thomas White the said

be now lies on containing one hundred pounds the same more or less
to him & his Heirs forever in full simple - time. I give & bequeath unto
my Daughter Ivernet the remainder of the said Money to be given together
with forty acres adjoining the same to her & her Heirs forever in full
simple - And as to my Son Charles & my Daughter Martha wife to
Daniel Robertson having given them formerly I make no further
provision for them in this my will; I likewise leave unto my Daughter
Ivernet all my Stock of Horses, Cattle & Hogs the plantation tools and
farming Utencils, my household & Kitchen furniture & all bedding
debt due to me, & all or any property belonging to me not herein
before mentioned, she paying out of the same the following sum viz
to my Sons James, John & George to each of them one dollar if they
come to receive the same within 12 months after my death, and
to my Daughter wife to William Clephane one Dollar & to my former
son in law Henry Hargett one Dollar, - And lastly I do hereby nominate
unto my Daughter Ivernet the sole Executrix of this my last will
& Testament, hereby revoking all former wills by me hertofore
made, In witness whereof I have hereunto set my hand & affixed
my seal this 16th day of January 1806.
