divided between the said five children, and to Robert
Cherrison I give one dollar but to his daughter Peggy I give
her fifty dollars to be paid out of my estate, and to Andrew Johnston
I give one dollar & to his wife eldest child of him by his first
wife my grand children I give them one hundred & eighty
dollars to be equally divided between them & to be paid said
children as they come of age by my executors clear of interest
except William Kerr as he has had contentions already I give
him & his wife one dollar, for my Negro woman Hannah
that I have let my daughter Jane have the use of, & the increase
of the said Hannah that she shall have after this date I give
to my daughter Jane increase that she may bear after this date
and the said Hannah to remain with my said daughter Jane
while alone bearing them at her own disposal, likewise I give
to my daughter James first daughter I give her a Negro girl
named with her mother named Felt & a Negro boy at the breast of
said Hannah named Aaron, and I give to my daughter James
second daughter a Negro boy named Sam & a Negro girl named
Isabel for ever - for my daughter Rachel I give her one Negro
boy named Thompson, one Negro girl named Polly & one named Jeff
and to my wife Mary I give her two Negro girls, Pearly & Peggy &
five hundred dollars in silver at her own disposal, and the
remains of any to be equally divided between my own born children
that is living at this time - And Lastly I do constitute &
appoint Jonathan Harris, Robert & William Benjamin as my
executors of this my last will & testament. In witness whereof
I have hereunto set my hand & affixed my seal this the 12th day
of May in the year of our Lord 1812.

and to my wife Mary I give her two Negro girls Pearly & Peggy &
five hundred dollars in silver at her own disposal and the
remains of any to be equally divided between my own born children
that is living at this time. And Lastly I do constitute &
appoint Jonathan Harris, Robert H. Lomb & Jozan Deakin as my
Executors of this my last will & Testament. In witness whereof

of May in the year of our Lord 1812.
