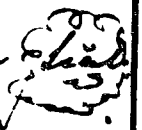

worldly Goods as it hath pleased God to bless me with, I dispose of them in the
following manner Viz - Item. I give & bequeath to my dear and

demands against the same is satisfied - Item I will & bequeath
unto my well beloved Son unrevoked the other third of the whole estate
Item. I will & bequeath unto my well beloved Son John the remaining
third of all my estate - Item I give & bequeath unto my daughter
in law Ann Ch. Jackson one and three years old here known by the name
of Muffs. - And provided it please God to remove by death either
of my above mentioned sons, I will & allow the survivor to enjoy
his part of the estate, & provided they both die, I will & allow
my well beloved wife to enjoy the whole of my said estate -

And Lastly I do hereby nominate & appoint my Trusty & well
beloved Friend Col. Nathaniel Alexander Esq. Thomas Polk Esq. &
Jacob Hanna to be my whole & sole Executors of this my last Will &
Testament utterly revoking & disannulling all former Wills &
Testaments & Establishing & confirming this as my last Will & Testament

now enlisted in the service of this province in order to quell the
Rebels & Rebellion now raised against the Government by the

God to call me out of this life, either by the hands of the common
Enemy, or by divine providence, Do therefore make & declare
this to be my last Will & Testament, As to my worldly Estate
whereunto God has been pleased to bless me with, I will devise
& bequeath in manner & form following that is to say
Impresure. I will that my beloved wife Barbara have possession
my dwelling house & plantation during her widowhood in order
to support her & three children now living with her untill they
marry or come of age according to the different sex & in case my
said wife should marry I will that she have one third part of
lands or one third part of the real yearly profits during her life
& in case of her death or her undue marriage again, I will that my
Executors do sell & dispose of my land in the best manner they can
& that the Money arising from the sale to be equally to be divided
between my children in General by equal portions except
