of this my last will & Testament, disowning all &  
every other, former wills Testaments & Legacies by me named written  
& witnessed before, Ratifying & confirming this & no other to be  
my last will & Testament; In witness whereof I the said James  
Hobson have hereunto set my hand & affixed my seal this 12<sup>th</sup> day  
of April 1797.

In the name of God amen, I John Hunter being weak in body but of  
perfect mind & memory thankes be to God, therefore calling to mind the  
mortality of my body knowing that it is appointed for all men once  
to die, do make & conclude this my last will & Testament, the testator  
herein partly & first of all I give & bequeath my soul into the hands  
of Almighty God that you will to be disposed of at his pleasure, &  
my body I command to the earth to be buried in a decent manner  
at the discretion of my executors — And as touching such worldly  
estate wherewithal it hath pleased God to let's me in this life  
I give & bequeath a part of the same in the following manner  
I give & bequeath a tract of land of Hunter's Bay about  
forty acres lying & being on the south side of Hunter's Bay about  
forty acres the plantation known by the aboreing his name  
the 4th corner in Wednesbord & the two big trees the black ones

and the bay. I allow to be kept on the plantation for the support  
of the family during my wife's widow hood & at her marriage  
it is my will that the black man be sold for them. the children  
the bay mare with three foals are bed & furniture. the Sh. of wood  
H. saddle & iron which I give they worth to my wife, I leave in  
the land & live on & allow to be sold by my executors at my de-  
ath or marriage, in the proportion of my children, the negro  
woman & child I allow to be kept on the plantation for to help  
to raise the children as long as she proves obedient & faithful  
to me. Mistress's commands & in case she proves disobedient I  
leave it to the discretion of my executors to manage with her  
as they may then think proper. Then I give the goods unto my  
beloved daughter Saripa in bed & furniture. And my Lord  
Lying in Beddy Room, I allow it to be left in the hands of my  
executors to manage with it as may appear most convenient  
to my children, and the remaining part of my perishable pro-  
perty I allow my executors to make a Vandue & sell, And my property  
I allow in the money arising from thence to be equally divided  
amongst all my children except the above mentioned property  
which I have particularly bequeathed to my wife & daughter  
Saripa. In the first place I allow all my just debts to be pa-  
id. And I now do hereby constitute & appoint my self Andrew  
Hunter & my Brother in law Nathan to be my sole executors.  
And my last will & Testament, And do hereby declare, that  
I disannul all & every other former will, Testaments, Legacies  
& bequests by me in any wise named, made or bequeathed before  
this day. Ratifying this same letter to be my last will & Testament  
In witness whereof I the said Andrew Hunter hath hereunto  
set my hand & affixed my seal this 9<sup>th</sup> day of September  
1804 - Signed, sealed, pronounced & declared by the said  
Andrew Hunter as his last will & Testament in the presence  
of us who in his presence & in the presence of each other  
have hereunto subscribed our names.

W. & Adelle & one which I give the rest to my wife, I mean  
The land & live on I allow to be sold by my Executrix at my u-  
limate or marriage, in the discretion of my children, the negro  
or child I allow to be kept on the plantation for to serve  
to train the children as long as she proves obedient & submissive  
to her Mistress's commands & in case she proves disobedient I  
have it by the discretion of my Executrix to manage with her  
as they may then think proper, These I give & bequeath unto my  
beloved daughter Sophia one bed & furniture. And my land  
lying on Peckey River, I allow it to be left in the hands of my  
Executrix to manage with it as may appear most convenient  
to my Children, and the remaining part of my perishable pro-  
perty I allow my Executrix to make a Vendue Roll, & all my property  
I allow to the money arising therefrom to be equally divided  
amongst all my children except the above mentioned property  
which I have particularly bequeathed to my wife & daughter  
Sophia — For the first place I allow all my just debts to be pa-  
id & I now do hereby constitute & appoint my self Hunter  
wife & my Brother in law Nathan & to my wife & daughter  
as my last will & Testament, and do hereby disallow, ren-  
ounce & disown all & every other Will, testament, Legacies  
& Executrices by me in any wise named, written or begon either before  
Himby Stating this & no other to be my last Will & Testament
