 unto Ann, now City her my beloved Daughters all the remainder
 of my Perishable property to be divided Equally between them -
 And I do hereby constitute & appoint Robert McHargue & Robert
 Robison both of Marlinton County State of N. Carolina to be my sole
 Executors of this my last Will & Testament, And do hereby utterly disown
 revoke & disannul all & every other former Wills & Testaments by me
 & Preceding by me named written or begun & made before, Ratifying &
 confirming this to be my last Will & Testament, In witness
 whereof, the said John Kerr have hereunto set my hand & seal
 this 28th day of May 1792 A.D. The wagon is to be for the use of the
 plantation & benefit of the family at large also I give to my in-
 heritor son William Kerr all my body clothes -

 & State of N. Carolina, being sick & in a low condition, but being
 of perfect mind & memory, thanking Almighty God for the same
 do make my last will & Testament after the following manner
 Imprimis. I Will & bequeath unto John Dickey for the use of
 winter congregation the sum of Twenty pounds. Item the remain-
 der of my estate after my funeral expenses & all other debts is
 discharged. unto the Estate of David Robison named
 Ambrose and Samuel Dickey's oldest Daughter Rachel to be
 equally divided between them to be possessed and enjoyed
 I retain & appoint my wife & sole Executrix of this my last
 will & Testament John Dickey & the rest young. And I
 do revoke all other Wills & Testaments made by me prior
 to this will. In testimony whereof I have hereunto set
 my hand & seal in presence of us this 5th day of April
 A.D. 1792.
