In the name of God Amen. The 30th day of October 1779
I Joseph Tamm on N^o Carolina North Carolina County (will
being very sick & weak in body but of perfect mind &
memory thanks be given to God, therefore calling to mind
the Mortality of my body & knowing that it is appointed
for all men once to die, do make & ordain this my last will
& Testament that is to say principally & first of all I give &
recommend my Soul into the hands of Almighty God that give
it & my body I recommend to the earth to be buried in a de-
cent Christianlike manner according to the discretion of my
Executors nothing doubting but at the General Resurrection I
shall receive this same again by the mighty power of God, And as
Touching such worldly Estate where with it hath pleased God
to bless in this life, I give & dispose of the same in the follow-
ing manner & form, And I order that all my just debts and
funeral charges be fully paid & satisfied. Item I give & bequeath
unto my beloved wife Ann Tamm the third of all my moveable
Goods & her Horse saddle & bridle & her bed & bed clothes & all the
house hold furniture & the negro woman called Jenn & her livery
on Ordering of this plantation & the two Mills as she thinks most
proper during her widowhood—Item, I give & bequeath unto
my eldest daughter Elizabeth Reed five pounds—Item I give &
bequeath unto my son John Tamm one hundred acres of land—
lying between my own plantation & Samuel Tamm's plantation
Item I give & bequeath unto my daughter Ann Reed five pounds
Item I give & bequeath unto my son James Tamm the plantation I now
live on & the two Mills & other utensils belonging to the said two Mills

And the black man that was formerly called his & of said man could be
 as concerning the negro John Fiddie that she have any share or like
 share they be divided between my two sons John & James & if my
 wife desire she be equally divided between the said John & James
 And also my wife Ann Tamm & my son John Tamm my only
 & sole Executors of this my last will & Testament & I do hereby
 utterly disallow revoke & disannul all & every other former Testa-
 -ment, Will, Legacy & bequeathments & contents by me in any way
 before named written & signified, Ratifying & confirming this to be my
 to be my last will & Testament, In witness whereof I have hereunto
 set my hand & seal the day & year above written -

 mind & memory knoweth in so sad a state, & desiring to resign the mortal-
 -ity of my body & knowing that it is appointed for all men once to
 die make constitute & ordain this my last will & Testament, that
 to say Presumptively I fear of all. I give & recommend my soul into
 the hand of Almighty God who gave it & my body to the earth to be
 buried in a decent Christian Burial at the discretion of my Exors
 nothing relating but I shall receive the same again at the general
 Resurrection thro' the mighty power of God, And wishing them
 worldly goods whereunto it be the pleased God to bless me in this
 life I give & dispose of them in manner & form as follow-
 -eth Viz I give & bequeath unto my dearly beloved wife Margaret
 one equal third part of my Estate after the payment of all just debts
 & my funeral charges & also she shall have the privilege of my place
 -ation I now live on to occupy the same & as not to alienate or
 it out of repair which Privilege she shall enjoy if she remain
 widow until my son & her Heirs shall arrive to the age of 21 years
