 I further will & bequeath to my said two children
 the said two cows to be kept for the use of the
 Children with the increase of the mares & two cows to abide in the
 hands of said brother & sister all for the Childrens use, I further will
 that if any one of said Children die before the said age the
 surviving one is Heir. I further will that all my other Effects be sold
 and I further will & bequeath to my loving sister Margaret Henderson
 the sum of Eighty pounds, I further will & bequeath to my loving
 brother James Henderson a bay mare called Bonny. I will that if my
 daughter Rebecca three hundred pounds be not in full it is to be paid
 in full by her Heir. Likewise constitute make & obtain my true
 & lawful Will & Testament in Witness whereof I have hereunto set my
 hand & seal the day & year above written —

 daughter Marys Children, I bequeath to my daughter Mary my own
 best & all my wearing apparel & two yards Linnen & what Linnen
 she has & one yard of Linnen. I bequeath to my son William five

 bequeath to my Grand son William son to my son William Twenty
 Shillings which is in his fathers hands, I bequeath to my Grand son
 Robert son to my son William three pound ten Shillings which
 is in his fathers hands only the above five Shillings excepted
 I bequeath to my Grand daughter Margaret Ferguson one pair
 bed & best clothes belonging to said bed & wheel & Reed & large
 basin & smothering Iron & looking Glass - I bequeath what money
 is due me by Robert & William Cochrane to be equally divided
 between my daughter Marys children, also the big white top
 daughter Margret, I bequeath one pound ten Shillings in gold
 which is in the hands of my son Robert to buy hats to Marys the
 oldest sons also the above excepted, Gold & silver to my grand
 Robert Ferguson - I ordain & appoint my sons Robert Harris
 William Harris Executors of this my last will & Testament
 In witness whereof I have unto set my hand seal this 11th
 of June 1789 before signing & sealing I bequeath to my son
 Harris one Cheff bed & blanket & one sheet also the Iron cross
 to Samuel Ferguson, and to three local pels to Marys children,
 the above being read to the Testator
