hundred dollars to be divided among them then & there alike  
payment to be made in one year after my decease

4<sup>th</sup>. I Will & bequeath unto my Daughter Matilda Hartshorn one  
hundred Dollars to be given her as her necessity may require at the  
discretion of my executors. I also will that my negro Girl Sarah  
with all her issue if any be divided amongst my grand children  
by said Matilda, but left with my said Daughter as long as my  
said Daughter shall live or at the discretion of my executors  
I also will unto my Grand Daughter Martha Hartshorn a bed and  
furniture to -

5<sup>th</sup>. I Will & bequeath unto my three Sons Mrs. John & William all my  
negroes (Except Sarah) with all my household & Kitchen furniture  
(The Bed & other above excepted). together with what Money may be  
left after paying all my debts & settling up the above legacies  
I also will to my said Sons the amount of the claim for money  
out of the price of the Land when sold as may appear by my  
Husband's last will & Testament -

Lastly. I nominate Appoint & Ordain William Neely & David  
McDonald Executors of this my last will & Testament. In witness  
whereof I have hereunto set my hand & affixed my seal this

4<sup>th</sup> day of November A.D. 1824.

hundred Dollars to be divided among them there & there  
alike payment to be made in one year after my decease.

3<sup>rd</sup>. I will & bequeath unto my three grand Daughters by Jane Agnes two  
hundred dollars to be divided among them there & there alike  
payment to be made as above etc.

4<sup>th</sup>. I will & bequeath unto my Daughter Malinda Hutchinson one  
hundred Dollars to be given her as her majority may require at the  
discretion of my executors, I also will that my Negro Girl Sarah  
with all her issue if any be divided amongst my grand children  
by said Malinda, but left with my said Daughter as long as my  
said Daughter's Natural life or at the discretion of my executors  
I also will unto my Grand daughter Martha Hutchinson a bed and  
furniture etc.

5<sup>th</sup> I will & bequeath unto my three Sons John, James & William all my  
negroes (except Sarah) with all my household & Kitchen furniture  
(the bed etc as above excepted), together with what money may be  
left after paying all my debts & settling up the above legacies  
I also will to my said Sons the amount of the claim for money  
out of the price of the Land when sold as may appear by my  
Husband's last will & Testament -

whereof I have hereunto set my hand & affixed my seal this  
4<sup>th</sup> day of November A.D. 1824.
