 hundred dollars to be divided among them when & there alike
 payment to be made as above &c—
 4th I Will & bequeath unto my Daughter Matilda Hutchinson one
 hundred Dollars to be given her as her necessity may require at the
 discretion of my executors, I also will that my negro girl Sarah
 with all her issue if any be divided amongst my Grand Children
 by said Matilda, but left with my said Daughter as long as my
 said Daughter shall live or at the discretion of my Executors
 I also will unto my Grand Daughter Martha Hutchinson a bed and
 furniture &c—

5th I Will & bequeath unto my three sons Moses, John & William all my
 negroes (except Sarah &c) with all my household & kitchen furniture
 (the bed &c as above excepted) together with what money may be
 left after paying all my debts & filling up the above legacies
 I also will to my said sons the amount of the claim for money
 out of the price of the Land when sold as may appear by my
 husband's last will & Testament—
 Lastly I nominate Appoint & Ordain William Neely & David
 Ch^o Deneo Executors of this my last will & Testament. In witness
 whereof I have hereunto set my hand & affixed my seal this
 4th day of November A^D 1824.

4th I Will & bequeath unto my Daughter Matilda Hutchinson one
hundred Dollars to be given her as her necessity may require at the
discretion of my Executors, I also Will that my negro Girl Sarah
with all her issue if any be divided amongst my Grand Children
by said Matilda, but left with my said Daughter as long as my
said Daughter's Natural life or at the discretion of my Executors
I also Will unto my Grand Daughter Martha Hutchinson a bed and
furniture &c.

5th I Will & bequeath unto my three Sons Charles, John & William all my
negroes (Except Sarah &c) with all my household & Kitchen furniture
(the bed &c as above excepted). together with what Money may be
left after paying all my debts & settling up the above Legacies
I also Will to my said Sons the amount of the Claim for money
out of the price of the Land when sold as may appear by my
Husband's last Will & Testament —

Lastly I nominate Appoint & Ordain William Neely & David
Ch' Donald Executors of this my last Will & Testament. In Witness
whereof I have hereunto set my hand & affixed my seal this
4th day of November A.D. 1824.
