Carolina & County of Lee shewing for the purpose of settling my earthly concerns & disposing of such Estate as it has pleased Almighty God to bestow on me, do make & publish this my last Will & Testament - First I recommend my soul to God, thro' Jesus Christ & my body to be interred in a Christian manner at the discretion of my Executors - 2^{dly} I direct all my just debts & several expenss to be paid. 3^{dly} I give & bequeath to my Daughter Mary A. Gison wife of John Robinson three hundred & fifty dollars, this sum I give & bequeath to her in full satisfaction to her share of my Estate hereafter given & bequeathed in consequence of her not having received any part of the Estate of my deceased Husband but the Henderson 4^{thly} I give & bequeath to my friends Andrew Henderson & Elizabeth Henderson & to the survivor of them & to their Executors or Administrators or to the survivor or survivors of such Executors or Administrators one riding chair new in possession of & bound by me to my daughter Harriet & to her wife of Andrew & Eliza Gison, the part of my whole Estate not otherwise given or bequeathed for the

And Intent & purpose herein after set forth to wit to the use, & for the sole & exclusive use of my daughter Harriet M^r Bride wife of Andrew M^r Bride & during the Term of her natural life & upon her death to be vested immediately & absolutely in such of her children as may be then living & legally. The remaining four fifths of my estate I give & bequeath equally between my Daughter Mary Robinson & my son Isaac Henderson & my daughter Eliza Smartt & Cornelia Hampton. 6th For the more convenient performance of the several bequests herein contained I hereby order & direct my whole estate to be sold by my Executors as soon as may be in the mode prescribed by Law. Except two large tracts of land & one large stand of Arrows which I give & bequeath to my daughter Mary Robinson 7th I give & bequeath all my wearing Apparel to be equally divided between my Daughters Mary Robinson, Eliza Smartt, Cornelia Hampton, and Harriet M^r Bride & my Daughter in law Lucretia Henderson 8th I do hereby nominate my Trusty friends Andrew Henderson & Gabriel Alexander Executors of this my last will & Testament In Witness whereof I have hereunto set my hand & affixed my seal this 9th day of October 1822 -
