 one Horse the getting her choice of all my horsefamels her first heffell  
 Likewise one bed & furniture there spicing wheel horses, likewise  
 cloring her two doore knobs as to my daughter Margaret & two of my  
 Brige pillars namely Dublin, also two boxes of my ship all which  
 she has privilidge to choose likewise all the household furniture to  
 the whole command of the plantation in relation to my son Sam  
 is of age, likewise all the implements fit for carrying on the plantation  
 Item, I give & bequeath to my son James all bonds, Notes & writing that is  
 due in my possession paid by me for him & his wife from Hollingshead money  
 Item, I give & bequeath to my son Oliver from Hollingshead  
 Item, I give & bequeath to my son John from Hollingshead  
 Item, I give & bequeath to my daughter Mary one bed & furniture beginning  
 wheel & one horse creature the getting her choice of the stock next after her  
 mother, likewise the Cattle & sheep that is not her own property -  
 Item, I give & bequeath to my son Samuel the one half of the plantation  
 I now live on when he comes of age his Mother to have the House I now  
 live in & the furniture & the command & care of the other half of the plantation  
 until her marriage or death which ever shall first happen, then  
 all the plantation to belong to my son Samuel Vnplements to carry it  
 on, Likewise one horse which is now his own property, Likewise one  
 Cow & Calf when he comes of age. — Item, I give & bequeath to my Daugh-  
 ter Hannah Wiley one Horse Saddle & Bridle to the amount of Twenty five

position of my Executor. Item I order all my lawful debts & funeral charges  
to be paid — Item I give & bequeath to my dearly beloved wife Margaret  
one Horse the getting her choice of all my son Samuel's horses kept  
Likewise one bed & furniture other spinning wheel / orna. Likewise  
during her widowhood as to my daughter Margaret one bed of best  
size & two pillows named Dublin also two boxes & one chest all which  
she has privilege to choose Likewise all the household furniture to  
the whole command of the plantation In relation to my son Sam'l  
is of age, Likewise all the implements fit for carrying on the plantation  
Item. I give & bequeath to my son James all bond, notes & receipts that is  
now in my possession paid by me for him likewise from Williams money  
Item. I give & bequeath to my son Oliver from Williams  
Item. I give & bequeath to my son John from Williams  
Item. I give & bequeath to my daughter Mary one bed & furniture beginning  
with one horse creature she getting her choice of the stock next after her  
mother, Likewise the Cattle & sheep that is not her own property —  
Item. I give & bequeath to my son Samuel the one half of the plantation  
I now live on when he comes of age his mother to have the House & now  
live in & the furniture & the command & care of the other half of the plantation  
until her marriage or death which ever shall first happen, then  
all the plantation to belong to my son Samuel & implements to carry on  
Likewise one horse which is now his own property, Likewise one  
Cow & Calf when he comes of age — Item. I give & bequeath to my Daugh-  
ter Hannah Wiley one Horse Saddle & Bridle to the amount of Twenty five  
pounds as the same command in money if she chooses, Likewise one cow  
& Calf at her marriage or coming of age which ever shall happen one  
feather bed & furniture other spinning wheel. Item. I give & bequeath to  
my Daughter Margaret one horse Saddle & Bridle to be valued to  
Twenty five pounds, Otherwise the same command in money if the  
choose Likewise one Cow & Calf, one bed & furniture other spinning  
wheel. All to be given her at her marriage or coming of age  
which ever shall first happen — Item. I give to my Master

Septem pounds to be made up out of my Personal estate he to get the legacy at his coming of age in case he gets leave to live with his Mother to that period of time after it is taken from her I leave him nothing. Item I likewise allow that part of my estate be accounted to my wife during her widow hood or to my deceasedes Marriage or coming of age to be sold at her Marriage or death, or my Daughter Margaret the plantation Bequeathed to me is to be excepted & kept back from her for my son James, The remainder to be sold & equally divided between my two Daughters Hannah & Mary Bellenger likewise if there be any Residue of my Estate not bequeathed I do allow it to be equally divided between my two youngest Daughters Hannah & Mary Bellenger and I do further allow if my wife should marry or digest this life before my two youngest Daughters Marriage or coming of age that my two daughters Hannah & Mary Bellenger shall go to both in equal place the make choice of in case my Executors thinks their choice Sustainable.

I do further constitute & appoint my beloved wife Margaret & my two Sons John Harris & Samuel Harris to be my Executors of this my Last Will & Testament given under my hand & seal the 10<sup>th</sup> day of Febby 1794

Item I Will & bequeath to my brother Robert Hunter Ten dollars Item I Will & bequeath to Mary Dealy my Sister my Sister & wife to James
